#### 6. ZONE BUSINESS

#### 6.1 State Government Support for Pensioner Rebates for Rates

#### **Executive Summary**

It is requested that WALGA advocate to the State Government to review the current \$750 and \$100 monetary cap for State Government rebates on local government rates and whether the monetary cap should be removed.

The amount has not increased since the implementation on 1 July 2015. It is recognised that the existing monetary cap amount is having a negative financial impact on pensioners. With the average residential rate amount being over \$1,500 in many local governments, the current cap is less than 50% of the annual local government rates payable.

#### **WALGA Policy Implications**

WALGA does have a position on extending the pensioner rebates to Waste charges under 2.1.7: Pensioner Discounts of Waste Charges however a review of the monetary cap applied to pensioners is not a position of WALGA.

#### **BACKGROUND**

Since 1 July 2015, the State Government implemented a monetary rate cap of:

- \$750 for a Pensioner Concession card holder or a State Concession card holder;
- \$750 for holders of both a WA Seniors Card and Commonwealth Seniors Health card; and
- \$100 for a holder of a WA Seniors card only.

The monetary cap outlined above has not been increased since its inception.

Prior to 1 July 2015, the pensioner rebate had no monetary cap and pensioners were entitled to a rebate of 50% of the total local government rates paid and 25% for a WA Senior Card holder only.

It is recommended that a review is undertaken in relation to whether a cap should be removed and the rebate is 50% of total annual local government rates.

#### COMMENT

The City of Mandurah has 10,144 pensioner held properties entitled to a rebate. Of that 10,144, if the 50% rebate on Local Government rates remained with an increased cap over \$750, 32.5% would benefit due to their total annual rates exceeding \$1,500. If the cap was removed and the rebate applies to 50% of the local government rates, the average increase to the rebate for the ratepayer on these properties amounts to \$165.

The City also has 2,104 ratepayers on a WA Seniors card only. The cap of \$100 for these ratepayers is low and inconsistent with the methodology applied to the pensioners, given that previously a 25% rate is in place. If a full pensioner at 50% is considered to be \$750, then using similar methodology, a WA Senior card holder should be entitled to a rebate of \$375.

#### **SECRETARIAT COMMENT**

The City of Mandurah's proposal aligns with WALGA's advocacy position that the State Government provide an annual CPI Perth Index increase to the rebate.

#### 6.2 Bauxite Mining Expansion and State Agreements

#### **BACKGROUND**

According to the Chamber of Minerals and Energy, the state's mining, oil and gas, energy and related industries contribute more than \$1.1 billion to the Peel economy every year and directly provide more than 6,000 jobs.

One of the most prominent resource operations in the Peel region is the Huntly Bauxite Mine and Pinjarra Alumina Refinery operated by Alcoa. Alcoa has operated since 1963 under various State Agreements (Alumina Refinery Agreement Act 1961 and the Alumina Refinery (Pinjarra) Agreement Act 1969). These State Agreements are acts of Parliament that intersect but occasionally pre date with environmental legislation.

In June 2020, Alcoa prepared documents to State regulators seeking approval to increase production at the refinery and secondly continue the supply of bauxite for export of:

- an increase in alumina production at the Pinjarra Alumina Refinery by 5% from 5.0 million tonnes per annum (Mtpa) to 5.25 Mtpa, and an
- increase in the rate of mining within ML1SA to supply up to 2.5 Mtpa of bauxite for export.

According to Alcoa's documentation published on the Environmental Protection Agency (EPA) website the proposal will require clearing of no more than 6,700 hectares (ha) of native vegetation within a 42,415 ha development envelope associated with mining, and an additional 10 ha of native vegetation associated with the refinery. 6,700ha equates to 67 km2.

In 2016, the Minister for State Development approved Alcoa to export up to 2.5mpta of raw bauxite up to December 2021. The export of raw bauxite allows for offshore processing and reduces the requirements on local refineries. According to Alcoa this represents about 7 per cent of the total bauxite Alcoa mines in WA annually at the Huntly and Willowdale mines.

#### COMMENT

The next stage of Alcoa's proposal is the preparation of the publication of an Environmental Impact Assessment (EIA). This EIA document is released for public comment of no less than eight weeks. Officer discussions with the EPA indicate that the EIA for the project could occur as early as December 2021. Officers from the EPA have indicated that typically proponents engage extensively with Local Governments prior to submitting their draft EIA to the EPA.

Alcoa's refinery operations are overseen by the State Government through the Mining and Management Program Liaison Group (MMPLG). The MMPLG which is made up exclusively of State Government agencies makes recommendations the Minister for Environment on the five-year rolling program of approvals and conditions for the operations in the area.

The role of the MMPLG is described by Alcoa as follows:

"The MMPLG was first established in 1978 and consists of representatives of the Department of Jobs, Tourism, Industry and Resources (JTSI), Department of Water and Environment Regulation (DWER), Water Corporation, Department of Biodiversity, Conservation and Attractions (DBCA), and the Department of Mines Industry Regulation and Safety (DMIRS).

Each year, Alcoa submits a five-year MMP to the MMPLG for review, which is approved by the Minister for State Development in whole or with conditions. The MMP sets out Alcoa's mining and rehabilitation schedule and includes priority land uses and management plans agreed through the MMPLG.

The current approved MMP for 2020-2024 authorises mining, for supply of bauxite to the Pinjarra refinery, of an average of just over 16.0 Mtpa (dry tonnes) per year at Huntly mine with associated clearing at an average of approximately 350 ha/year over the five-year period. This includes mining for up to 2.0 Mtpa (dry tonnes) of bauxite for export in 2020 and 2021."

The MMPLG is an important body that makes recommendations to the Minister on Alcoa's operations but lacks local government input. A change to the MMPLG membership would require a revised Ministerial Statement issued for the project by the Minister for Environment as the 2006 Statement only includes membership from State Government entities.

Alcoa's existing and proposed operations represent a significant economic and environmental project for the entire Peel region and span the Local Government areas of Serpentine Jarrahdale, Murray and Boddington.

State Government regulators note the importance of extensive engagement between mining operators and Local Governments. In practice, this engagement can be challenged by the complexity of the legislative framework that significant mining entities such as Alcoa operate within. Local Governments have limited capacity to navigate this complex legislative framework to ensure that they best leverage available opportunities to represent community interests.

Given the complexity of the legislative framework broadly, there is reason to believe that this is a common concern across local governments in the State and is not unique to the Peel or the legislative framework that Alcoa is operating within.

It is recommended that that Peel Zone recommends that the WALGA State Council adopt a policy position calling on the State Government to prepare and publish a toolkit to assist local governments in working with mining operators bound by State Agreements.

Such a toolkit would be useful for local governments state-wide and potentially reduce expenditure on legal advice and environment consultants being sourced by Local Governments that have mining operations in their districts bound by State Agreements. This type of toolkit would also be useful for Local Governments and the community in understanding the opportunities for local community participation and the limits of participation in decision-making thereof.

Individually, Peel Local Governments have also identified concerns with the currency and compliance status of various State Agreement Acts. When queries have been formally raised about State Agreements and company compliance with such, Local Governments have been directed to engage with the proponent rather than the regulator. A review of the currency and compliance status of these State Agreement Acts is required to ensure that aims of the State Agreements are being achieved.

#### 6.3 Regional Telecommunications Review

#### **BACKGROUND**

A Regional Telecommunications Independent Review Committee (the Committee) is established every three years under Part 9B of the *Telecommunications (Consumer Protection and Service Standards) Act 1999* to conduct a review into telecommunications services in regional, rural and remote parts of Australia.

The Committee for the 2021 Regional Telecommunications Review (the Review) was appointed on 1 June 2021.

The 2021 Committee is comprised of the Hon Luke Hartsuyker (Chair); Ms Kristy Sparrow; Professor Hugh Bradlow; Mr Michael Cosgrave; and Ms Sue Middleton.

The Committee is also conducting consultation sessions and as the dates for these are announced via their website Local Governments within the area being consulted are being advised via email of the upcoming process and encouraged to participate.

As part of the Review, the Committee will consider:

- the impact of Government policies and programs to improve regional connectivity and digital inclusion;
- insights from COVID-19 on the changing digital needs of regional, rural and remote areas;
- service reliability issues which impact regional communities and options for mitigating them;
- the role of emerging technologies in delivering telecommunications services in regional Australia;
- ways of encouraging further investment in regional telecommunications;
- the role of telecommunications in supporting broader regional development goals;
- ways to improve co-ordination between government and industry in telecommunications investment; and
- consumer awareness and education regarding telecommunications options in regional areas.

The full Terms of Reference for the Review are at Appendix B of the Issues Paper.

The Consultation Period runs from 6 July, 2021 09:00 to September 30, 2021 with WALGA receiving submissions until COB Thursday 16 September 2021.

#### **WALGA Engagement Process**

Local Governments were advised in mid-July, via Councillor Direct, of the appointment of the Committee and the release of the Issues Paper, and that WALGA would be developing a sector wide submission.

WALGA, in developing a submission to this important review is seeking the views of members to address the wide range of telecommunications issues outlined by the Committee in the Regional Telecommunications Review 2021 – Issues Paper (the Issues Paper).

Local Governments have been requested to provide their submissions or information to inform the sector wide submission to the Association to ensure all matters are addressed.

This agenda item provides a Zone level opportunity to provide feedback to the WALGA submission to assist in ensuring all Local Governments have had a chance for input.

#### COMMENT

Zones are requested, however not limited to, consider the items outlined at the dot points and /or the individual questions outlined at the end of each section or at Appendix A of the Issues Paper or provide input on any related matter for inclusion in the submission.

By way of example the WALGA Submission will include, in part, commentary on Question 12 that asks:

'How can different levels of Government, the telecommunications industry and regional communities better co-ordinate their efforts to improve telecommunications in regional Australia?'

The Association response will include an example of the Regional Telecommunications Resilience Working Group established in May comprising key planning/technical staff from Telstra, Optus, Western Power, Horizon Power, WALGA, DFES and DPIRD. This working group will share data more openly to allow robust and coordinated planning which results in better overall service delivery and value for money for all concerned. The working group began its work in June 2021 and have scheduled monthly meetings that increase as Funding programs or issues emerge.

WALGA advocates on specific issues identified by its members at the Working Group, in particular to explore opportunities for sustainable solutions e.g. Stand Alone Power provision, utilising a combination of solar, batteries and generators.

The Association is keen to provide a comprehensive submission on this important matter and welcomes Zone input.

#### 6.4 Social Housing Economic Recovery Package Grant Funding

#### **BACKGROUND**

The \$319 million <u>Social Housing Economic Recovery Package (SHERP)</u> is part of the State Government's COVID-19 Recovery Plan announced in June 2021.

The Program aims to provide safe and secure housing outcomes for vulnerable Western Australians by supporting the construction of new community housing properties and the refurbishment of existing properties to extend their useful life or increase their capacity. Grants are also available to fund maintenance works within remote Aboriginal communities.

Local Governments are eligible to apply for SHERP grants and partner with existing social housing providers and community groups within their communities.

The next round of SHERP funding opens on Monday 1 September 2021.

Further information on the eligibility requirements and application process for the SHERP grants will be provided by the Department of Communities at a webinar to be hosted by WALGA on **Monday 1 September** from 1.30pm – 2.30pm.

#### 6.5 2021 Local Government Elections – Zone Office Bearer Elections

#### **BACKGROUND**

With the bi annual Local Government elections being held Saturday, 16 October 2021, Zones will also be required to hold an election process for State Council representatives.

A chronological overview of the process is detailed below:

- Local Government elections occur on Saturday, 16 October 2021.
- Member Councils to elect/appoint their Zone Delegates and to advise the Zone Executive Officer, as soon as possible but preferably by 5 November 2021.
- For the purpose of electing their representatives and deputy representatives to the WALGA State Council, the zones are required to hold these elections at their November 2021 meeting.
- Zones to advise WALGA, in writing, of their elected State Council representative and deputy representative immediately following the 2021 November Zone meeting.
- State Councillor Induction Session morning of 1 December 2021.
- New State Council will take office at the Ordinary Meeting of State Council on 1 December 2021.
- The position of President and Deputy President of WALGA, will be elected at the March 2022 State Council Meeting.

In relation to the nominations and election process to be followed by each Zone in electing a representative and deputy representative to the WALGA State Council, the below process has been instituted by State Council:

- 1. Zone Executive Officer to write to all Member Councils no later than 1 month prior to the Zone meeting at which the election is to be held calling for nominations from delegates to the Zone for the positions of representative and deputy representative to State Council. The correspondence is to state that all nominations are to be made in writing to the Zone Executive Officer, and only Elected Members who are a nominated Zone delegates are eligible to nominate. The time period for the receipt of nominations is to be one week prior to the Zone meeting at which the election will be held.
- 2. Zone Executive Officer to receive written nominations from Zone delegates for the positions of representative and deputy representative to State Council and then provide written confirmation to Member Councils of the nominations received.
- 3. Elections are to be held at the next Zone meeting as the first item of business. Where there is more than one nomination for each vacant position, an election will be conducted using a secret ballot, with the Zone Executive Officer to represent WALGA as the returning officer for the election. Prior to the ballot, nominees for each position are to be extended the opportunity to provide a 2 minute election bid to delegates.
- 4. All voting delegates to the Zone are entitled to cast one (1) vote in the ballot process. The candidate with the greater or greatest number of votes is elected to the office.
- 5. **Tied vote** in the event of a tied vote, election will be determined by drawing names from a box. The Secretariat will put the names of the candidates concerned in a box and the first name drawn is the Elected Member.
- 6. Zone Executive Officer to advise WALGA in writing immediately following the Zone meeting of the outcome of their elections.
