Executive Summary

- The Corporate Governance Charter provides for the establishment of Policy Teams, delegated Committees and Policy Forums.
- State Council made appointments to the Finance and Services Committee and the four Policy Teams at its 1 December 2021 meeting. Appointments to the remaining Committees and Policy Forums was referred back to the Secretariat.
- Nominations from State Councillors for the positions available were opened on Monday, 14 March and closed at 5:00pm on Monday, 21 March.
- The purpose of this item is for State Council to confirm all appointments to the Committees and Policy Forums listed below, as well as confirm amendments to the Corporate Governance Charter in relation to membership of the Honours Panel and Selection Committee.

Background

Pursuant to the <u>Corporate Governance Charter</u>, State Council has established several Committees with delegated powers. Clause 19 of the Corporate Governance Charter outlines the membership and terms of reference of the Committees.

At the 1 December meeting of State Council, appointments were made to the Finance and Services Committee and the four Policy Teams. However, State Council resolved to refer appointments to the above Committees back to the Secretariat in liaison with the then Acting WALGA President, Cr Karen Chappel, for consideration.

The appointments will be confirmed at this special meeting of State Council.

Changes to the Corporate Governance Charter

The <u>Corporate Governance Charter</u> details the terms of reference and membership of each of the State Council Committees with delegated powers. Currently, the membership for the Selection Committee (clause 19(iv)) and the Honours Panel (clause 19 (v)) includes only one Metropolitan State Councillor and one Country State Councillor. It is proposed that the membership is increased for both Committees to two Metropolitan State Councillors and two Country State Councillors.

By increasing the membership of these Committees it provides greater opportunities for State Councillors to be involved in the Honours and Selection processes. Increased membership also makes it easier to achieve quorum, which gives the Committee more flexibility.
