Road issues

Cr Chris Paylovich

- Cr Pavlovich has been appointed to the State Road Funds to Local Government Committee.
- 20% of licence fees go to State and Local roads. 2 years into 5-year agreement. Will be lobbying to get that percentage increased. \$28.5 million underspend on roads last year. Difficult to get increase when there's an underspend.
- Also underspend of Regional Road Group money. RRGs can put better systems in place to acquit all of the funds. Councils need to submit paperwork in the same financial year.

Cr Len Handasyde, Chairman, Great Southern Regional Road Group

State and Federal Blackspot projects - spending target is 90% but have only met this target once in 5 years. Ditto for other funding. KPIs - meeting % of roads assessed. Meeting Safe Systems but not database loading. Main Roads know what projects are completed but councils need to submit paperwork in same financial year. Have made improvements but need further improvement. Need to reach 100% target.

What are the impediments? Sometimes services relocation, boundary adjustments, clearing permits, etc. 3 year rolling average might service better.

Everything got funded for 2020-21 so councils need to carry out the work.

Cut off date to submit paperwork is 16 June 2021. Needs to be serious discussion about reaching the target. GSRRG has advocated for more passing lanes on Albany Highway and improvements on State roads such as Chester Pass Road and Muir Highway. Zone requested to have a position statement on these roads. Need to link with CBH's 100 receival sites for the future. Statement from Zone would benefit GSRRG. Lower level of local roads maintained from Local Government funds - standard of these roads needs to improve.

Cr Fleav

- Zone needs to advocate and treat this as an emerging issue.
- Could have Zone working group to advocate for road improvements.

Stephen Gash

State road agreement - RRG is on that committee. Can put roads to identified bucket of money.

- Issue with GROH (Government Regional Officer Housing) in Nyabing is progressing.
- Decommissioning of fire vehicles came out of Ferguson Report recommendations. SEMC meeting
 was going to closed off this issue but WALGA said it was still live matter in Great Southern.
 Richard Burnell at DFES is handling this. DFES has declined trial of new fire appliance fit out but
 agreed to consultation in regards to how to equip bush fire fighting appliances. Mr Burnell is willing to
 attend Zone meeting to discuss.
 - Woodanilling is pursing vehicle de-commissioning issue through Upper Great Southern ROAC. There are some anomalies which need to be considered. WALGA is advising DFES about what Local Governments are experiencing. Future Fleet has been resolved and is called Operational Fleet Programme.
- Recommend asking DFES representative about Code of Conduct for DFES Bushfire Fire Brigade members. Refer to attachments from MLA Terry Redman.

City of Albany

- Albany Airport will have flights increase to 13 a week from 31 August 2020.
- Record months for accommodation in Albany due to State border restrictions leading people to holiday on south coast.

Shire of Broomehill-Tambellup

- Broomehill fire station completed.
- Issues with Water Corporation.
- DEMC raised issue of labourers for farmers due to restricted overseas travel.

11. Emerging Issues for Local Government - continued

Shire of Jerramungup

- Drought projects are not being signed off but still required have funds expended by late June 2021.
- Still without a permanent doctor servicing Jerramungup and Bremer Bay.
- \$4.2 million funding for swimming pool.
- Appointed a Bushfire Risk Mitigation Officer who starts on 14 September.

Shire of Katanning

Talking with WALGA about changes to Code of Conduct for bushfire volunteers.

Shire of Kent

- Getting positive results by lobbying for teacher housing. State Government is keen to engage with councils who have the ability to contribute funds to build housing.
- Water is a big issue everywhere. Pingrup's small sub-division housing initiative will have lots available for the future but the Water Corporation says the water system has limitations and is at capacity.
- Drought Communities grant application submitted. They will assess applications and then recommendation to Minister - could take at least 8 weeks. The time lag is disappointing as communities need to spend funds by late June 2021.
- Submitted application for Heavy Vehicle Productivity Grant.
- Feedback on Native Title Settlement Nyabing has Dept of Education land which could be part of settlement package. Shire of Kent is working with Dept of Planning, Lands & Heritage to oppose this.

 Peter Northover advised that there were delays in getting access to drought money on the government portal.

Shire of Kojonup

- Sport and Recreation funding disappointing that they are dictating what the money is spent on. Lack of flexibility.
- Re-wiring at airstrip.
- Medical Centre should be completed in about 6 weeks.
- Housing project almost up to lock up stage.

Shire of Plantagenet

- Due to earlier concerns about declining population in rural areas, the Shire of Plantagenet spent
 money to upgrade the town with landscaping and improving boardwalks with a view to attracting new
 residents and tourists.
- Swimming pool building will be replaced after Christmas.

Shire of Woodanilling

- Overlap with Bushfire and DFES advisory committees. Minimum training standards for volunteers. Aim to make it more flexible and relevant Katanning, Broomehill-Tambellup and Woody met with DFES. Training is 2 days at a time but struggling to get volunteers for 1 day. Consulted LGIS and their lawyers advised that scheme will cover all volunteers, defined as someone at the direction of the CBFO. Local Governments have same duty of care as an employer. If there is an incident, could mean LGs are liable. Has caused a dilemma. Woody is seeking further information from DFES. This is an emerging issue which could gain some traction going forward.
- Emerging opportunity renewed momentum for tourist rail down Great Southern railway line. EOI going out for parties to become involved. Kevin Gale has done a lot of work on this. Any shire along the railway line will become a stakeholder. ARC Infrastructure supports having this on the rail line.
