#### 5.2 Business Arising

Refer to the attached Status Report from WALGA to the Zone dated December 2018 for the following items:-

#### 5.2.1 Fires affected mobile phone service in regional areas - Shire of Jerramungup

Jerramungup CEO has spoken with Telstra about installing generators which could power mobile phone towers in emergencies.

Woodanilling loses its exchange and power so has no communications at all in emergencies. Telstra is investigating. This is a significant issue throughout the state.

#### 5.2.2 Appeals against native vegetation clearing permits - Shire of Jerramungup

Cr Keith House raised this as an emerging issue at the September WALGA State Council meeting.

Update: Letter to the Zone from Wildflower Society of WA was circulated and discussed. Cr House advised that he had discussed the letter with delegates / councillors at the November meeting of the Great Southern Regional Road Group where the consensus was to discuss the letter at the Zone meeting for an appropriate response.

Resolved: Mal Shervill to consult with Mark Batty about the Zone discussion and assist with drafting an appropriate response letter to the Wildflower Society of WA. Draft letter is to be reviewed by Zone member councils before being sent. If required, the Wildflower Society's minutes might be requested in order to verify that the vegetation clearing sub-committee has authority to act on behalf of the Society.

Other ongoing issues:-

#### 5.2.3 Local Government Act Review Forum held in Cranbrook on 19 October 2018

The following documents were tabled:-

- Facilitator's report from the forum.
- InfoPage from WALGA.
- Matters for Noting Item 6.1 in the December 2018 WALGA State Council Agenda.

The WALGA process from here is as follows:-

 16 November 2018 – WALGA distributed an InfoPage requesting Local Governments (Council decision required) to provide a submission on the Act review process. A submission to WALGA is requested by 22 February 2019. This will enable Councils to consider an item at their December meetings.

- November Zone Meetings/December 2018 State Council Meeting Item for noting will be prepared that will cover information on the Local Government Act review process and a summary of the forums held in October/November and general themes coming through.
- February Zone Meetings/March 2019 State Council Meeting Item for Decision on sector positions feedback following feedback from Local Government submissions.

## 5.2.4 Policy for Restricted Access Vehicles on Roads not on an Approved Network During Harvest

- The link to Main Roads WA's Harvest Mass Management Scheme website was emailed to all Zone councils in early September for dissemination within their communities.
- Main Roads WA officers gave a presentation on the Revitalising Agriculture Region Freight Strategy in Cranbrook on 19 October 2018.

#### 5.2.5 Target Issues for the Zone in 2019

For discussion including suggestions for guest speakers in 2019.

#### Roads

Specific examples of sections of grain freight roads which need upgrading will need to be provided to the Executive Officer before a further request to the Minister for Transport to attend a 2019 Zone meeting is made.

#### • Unmet labour need in the Great Southern.

Proposed changes to Federal immigration rules and broader migration issues. Need to relocate people out of cities into regional areas to fill vacancies such as medical services. Promote quality of life in rural and regional areas.

The Kojonup case regarding a Registered Nurse not being allowed to stay on at the aged care facility has gone to WA Health Minister Ben Wyatt and to the Federal level. Peter Rundle and Rick Wilson are aware of this issue.

Currently, the Great Southern regional has 3.5% unemployment which is classed as full employment, and is evident across all skilled and unskilled jobs in the region. Cr Rob Lester commented that health positions are often advertised as temporary and not permanent.

ACTION: WALGA to investigate avenues to pursue this issue.

#### Economic development

Economic development reports from session at Local Government Week 2018 were circulated with the November Zone agenda.

#### 5.2.13 Unmet labour need in the Great Southern

Abattoir, agriculture and health industries are relevant for the Great Southern.

Transient labour in vineyards.

Cr Keith House - lack of connection from a regional perspective to the migration issue. Need to bring decision-making on migrant visas back to a local level.

Cr Chris Pavlovich - keeping skilled jobs for our young people but fill unskilled jobs such as vineyard positions with visa workers.

Mayor Dennis Wellington advised that unless you get a direct line into Canberra, it's a waste of time.

#### 5.2.14 Road Toll Statistics - Shire of Broomehill-Tambellup

Cr Keith House advised that the road toll statistics are formulated the same nationwide. No further action. Remove this item from next agenda.

## 6. ZONE BUSINESS

#### 6.1 Emerging Issues for Local Governments

Zone councils to give an overview of emerging issues affecting them over the past few months.

#### City of Albany

- Discussion with Minister for Transport about Albany Ring Road.
- Field of Light is exceeding expectations 40,920 people in 8 weeks. Predicted 30,000 in 8 months.
- Application for 108-room Hilton Hotel on Albany waterfront.
- 43 companies downloaded info on Middleton Beach hotel and 43 came back saying not interested in the current economic environment.
- Review of Container Deposit Scheme feedback by 6 December 2018 for customer service standards for collection depots. CDS proposed to be introduced by early 2020.

#### Shire of Broomehill-Tambellup

- Approval for another development at CBH in Broomehill. Planning for 300,000 tonne capacity.
- Visit by Grants Commission very supportive.
- BBRF housing project delayed because some Local Governments have changed their scope of works. Rick Wilson informed of the delay.
- Cr Mark Paganoni requested clarification from WALGA staff about where they are coming from in wanting CBH to be rated.

Mal Shervill - rateable review has identified many charitable organisations which are not paying rates. The net has been cast and some fish caught that maybe should not have been. Cr Keith House - important for councils to provide feedback on rating issues via the Local Government Act Review by 22 February.

Mayor Dennis Wellington gave the example of a community of 180 RAAFA houses in Albany not paying any rates but the City of Albany is providing infrastructure and services which benefit the residents of this community.

#### **Shire of Cranbrook**

- Carry over funding approved for ablution block at new truck bay on Great Southern Highway.
- Draft masterplan for airstrip has been received and will be reviewed.
- Awarded a double header event for motorcross.

#### **Shire of Denmark**

- Corporate Business Plan adopted.
- \$1 million worth of work on oval awarded to local contractors.
- Industrial area work progressing and should be completed within weeks.
- Award jointly received with City of Albany for innovative management for Great Southern peer support programme.

#### **Shire of Gnowangerup**

 Gnowangerup 360 is not a council project but the council hopes for a good outcome for retail small business in the town.

#### **Shire of Jerramungup**

 Problems with boat ramp at Bremer Bay. Law suit from someone who broke their ankle on the ramp. Dept of Transport wants to close the whole facility and wash their hands of it. Repairs have been made. Would be good to get Minister of Transport to comment on this issue.

#### Shire of Katanning

- BKW Co-op went into voluntary administration but local consortium plan to re-open in February / March 2019.
- Council's new administration building should be finished at the end of January 2019. Official opening at end of February.
- Construction of new playground has been awarded.
- Changing Places toilet at Lions Park.
- New RV park and relocated dump point will attract people closer to town centre.
- Co-location of bowling club.
- Around 85% occupancy at new Premier Mill Hotel. Australia's South West board dinner held at the hotel recently.
- Many of Katanning's transformation projects will be finished in 2019 good for the region.

#### Shire of Kent

Community inn expected to open end of January 2019.

#### Shire of Kojonup

- Waiting for housing project to start.
- People stayed in Kojonup on way to road conference in Albany. Good partnership.
- Tourist train still not operating. Rail regulator is stone-walling. Compliance is unreasonable. LGIS has been a huge help.
- Community Resource Centre serious change needs to occur.
- If NSW can take on Registered Nurses in aged care facilities, why can't WA?

#### **Shire of Plantagenet**

- Plantagenet is still achieving 2% growth.
- Land Corp dragging its feet on industrial park. Now looking at funding 3-4 initial blocks.
   Developers complaining of high cost of utilities installation in rural areas.
   Cost of water to industry is sometimes 6 times more than the metro area.
- Hospital is under-used. Looking at staff sharing with Albany and Denmark.
- South Coast Alliance economic development strategy.

#### Shire of Woodanilling

- Telephone communications zero communications when power goes down.
- CEO Belinda Knight is moving on after 17 years with the council.
- Received \$200,000 funding for bushfire risk mitigation.
- WANDRRA funding project completed.
- Grants to put in better facilities at Lake Queerearup.

Item 5.1 Proposal to abolish Letter of Approval - CA07 Condition

Mal Shervill - WALGA still in discussions with Main Roads. WALGA submitted Local
Government's position to MRWA. Main Roads needs to keep talking to WALGA.

WALGA opposes withdrawal of the 'Letter of Approval' Restricted Access Vehicle Operating
Condition until an acceptable alternative is developed.

- Do any councils have concerns about upgrades to CBH sites?
   Mayor Dennis Wellington said Albany did not approve of CBH using extra long trucks due to lack of passing lanes between Albany and Ravensthorpe. CBH has now shelved this proposal.
- Zones are requested to consider for endorsement the amendments to the Group's Terms of Reference. The amendments provide for:-
  - > PGA of WA and WA Farmers to become non-voting participates on the Group.
  - Deleting the President of WALGA as a formal member. When the Group was first formed the WALGA President was actively involved. In recent years the WALGA President involvement has diminished and they no longer attend meetings. The Group felt it was appropriate to remove the reference to the WALGA President. WALGA is represented by the Executive Manager for Infrastructure at an administration level.

#### 12.0 GUEST SPEAKER

#### Mick Irving - Manager, Customer and Stakeholder Great Southern, Water Corporation

#### Standpipe categories

- Local Authority Standpipe at subsidised rate of \$2.50 per kilolitre.
- Community standpipe is 20-25 mm with slower flow rate small quantity use for domestic purposes for those who are not on scheme water at subsidised rate. Councils can put in a water tank with camlock fitting which will allow water tanks to be filled more quickly.
- Fire standpipe use for fire purposes only and locked.
- \$8.50 per kilolitre for commercial rate.
- Price depends on how close to water source sites are.

#### Other points:-

- Card systems Local Governments can claim back water usage at subsidised rate where eligible.
- Water Corporation will credit councils if the Water Corporation takes water from standpipes from time to time.
- Water Corporation does not charge for water used in emergencies.
- During declared drought, all prices revert back to subsidised rate during the declared drought period.
- Water Corp will install free 20-25mm community standpipe infrastructure.
- No barriers to Local Governments recovering their costs for water supplied to other users as long as no GST is charged.

ACTION: Water Corporation to meet with all councils to discuss their standpipes.
