Tim Lane provided an update from Executive Manager Infrastructure, Ian Duncan, in relation to the formation of a working group to consider alternatives to the CA07 operating condition, as follows:

Senior staff from Main Roads Heavy Vehicles Services have agreed to participate in a reference group with Local Governments to consider alternatives to the CA07 condition that applies to RAV access on some Local Government roads. The officers are required to provide a briefing to the Minister for Transport prior to working with Local Governments on this matter, given both the legal considerations and that this matter has been the subject of several questions in Parliament. It is our understanding that the Ministerial briefing has been prepared but not yet approved for forwarding to the Minister. The CA07 condition remains in place while work on an alternative or modified approach continues.

## 5.2 Financial Assistance Grants Allocations

## Secretariat Comment

WALGA has consistently supported advocacy, through ALGA and other channels, for increases in funding from the Commonwealth Government to Local Government through Financial Assistance Grants.

ALGA's number one priority in their Federal Election advocacy strategy is to restore Financial Assistance Grant funding to one percent of Commonwealth taxation revenue.

There have been discussions over the years relating to the method of distribution of Financial Assistance Grants, which are guided by Commonwealth legislation. In particular, these issues were considered as part of the Systemic Sustainability Study (SSS) (2005-2009), and the Commonwealth Grants Commission conduction a review of Financial Assistance Grants in 2012-2013.

The National Principles for the allocation of grants under the *Local Government (Financial Assistance) Act 1995*, are:

- 1. Horizontal Equalisation
- 2. Effort Neutrality
- 3. Minimum Grant (per capita basis)
- 4. Other Grant Support
- 5. Aboriginal People and Torres Strait Islanders
- 6. Council Amalgamation

State Council's submission to the review conducted by the Commonwealth Grants Commission in 2013 argued that the quantum of funding to Local Government should be increased, and argued in favour of the following:

- Improved service provision for Indigenous communities would be more appropriately addressed through tied grants, rather than untied FAGs funding;
- FAGs funding should remain an untied, rather than tied, source of funding for Local Governments; and,
- The Minimum Grant principle should be retained in its current form.

## **RESOLUTION**

## That WALGA:

- 1. Be requested to review the current Grant Commission allocation methodology, including the minimum grant, and the continuing suitability of the allocation methodology; and,
- 2. Advocate to the Minister for Local Government and ALGA to request a review of the Financial Assistance Grants methodology, particularly the continuing applicability of the minimum grant.
