WALGA has been working with the South West Aboriginal Land and Sea Council, Department of Planning, Lands and Heritage (DPLH) and Department of Premier and Cabinet (DPC) to develop a template Noongar Heritage Agreement for use by Local Governments within the area of the South West Native Title Settlement (SWNTS).

It is anticipated that the Draft Agreement will be circulated to State Council by Flying Minute for endorsement within the next week or two, and included as an Item for Noting on the next State Council Agenda.

A representative from the Department of Planning, Lands and Heritage would like the opportunity to present to the Central Metro Zone and provide an overview of the template Agreement and an update on the progress of new Aboriginal heritage legislation for WA.
