#### 7. OTHER BUSINESS

# 7.1 WALGA State Council Agenda Content

Zone Members held a general discussion regarding the content of WALGA State Council Agenda and noted that the current agenda contained a number of Interim Submissions, which only provide Zone's with the ability to make minor adjustments to wording.

Zone Members noted their discussions in a workshop held following the 26 June 2019 meeting, at which the Zone advised their preference for WALGA State Council agenda to focus on proactive strategies to influence State Government policy directions rather than just respond or react to State Government proposals.

Ms Lin left the meeting at 7.04pm and returned at 7.08pm.

# 7.2 Local Government Role in Building Control

Zone members discussed their concerns with the State Government's management of building control and safety issues and the role State Government was expecting Local Government to play, without appropriately legislative functions prescribed. Issues discussed included the combustible cladding issue, exploding glass and lead in water from imported brass plumbing fixtures.

The recent Office of the Auditor General (OAG) Report was also discussed, with the Zone noting that the OAG Report erroneously made recommendations regarding Local Government functions for monitoring and inspecting building works, which are not currently functions of Local Government (permit authorities) under the *Building Act 2011*.

Ms Fogg advised the Zone that WALGA wrote to the OAG several weeks ago requesting that their Report be corrected to remove comments that are not aligned with the actual role of Local Government under the *Building Act 2011*. The OAG has advised this week that a response will be provided shortly.

Ms Fogg also advised that WALGA State Council had resolved in March 2017 a 'Top Ten' Issues for improving the operation of the Building Act 2011, all of which align with and cover the majority of the Recommendations of the February 2018 Shergold Weir Report. WALGA met with the Minister for Commerce earlier this year to strongly advocate for legislative changes to support the State Government in better managing future safety issues with building products and for the WALGA Top Ten issues to be prioritise by the State Government for review of the Building Act 2011.

Zone members commented that community confidence in building standards was vital for the achievement of infill density targets.

Zone members also raised regarding the Builder's liability for the structural integrity of buildings being only six years, considering community expectations that the builder should be held liability for a longer period.

Zone members AGREED that Mr Ian Cowie consult with Ms Fogg to develop appropriate wording for a motion that will be circulated by 'flying minute' for Zone member's approval and inclusion in these minutes.

A draft motion was circulated by email on 30 August 2019 and was subject to amendments proposed by Mayor Cr Henry Zelones and Mayor Cr Sue Doherty, with the following amended motion proposed:

#### That WALGA Officers:

- 1. Continue to advocate for the "Top Ten issues" resolved by State Council in 2017 and prepare a State Council report detailing the current status of WALGA's advocacy on building safety, structural integrity and regulation issues;
- 2. Consult with the sector to determine what the role of Local Government should be in building regulation control; and
- 3. Develop an advocacy strategy on behalf of Local Governments for State Government to urgently prioritise legislative reform that addresses systemic failures that are eroding confidence in the safety and structural integrity of buildings in Western Australia.
