6. BUSINESS

6.1 Localeye - Smart Phone App Discussion

Discussion requested on WALGA Localeye App.

Secretariat Comment

WALGA initiated Localeye as a free smart phone app to assist Local Governments to engage with their communities.

It currently has functions by which users can locate Local Government services and facilities, access news, events and information about their Local Government and report issues to their Local Government. The app also has an offline function for when travelling to areas with poor reception and alerts for DFES advice. The app is available on the Apple and Android platforms and each Local Government has a designated portal they can access to update news and events information. There is no charge to Local Governments for the app or the portal.

By way of background, Localeye was developed from an initial project to provide Local Government with its own reporting app to help circumvent emerging third party apps such as "fixmystreet" that operated in the UK and was used to publically criticise councils. However some Local Governments objected that the app would create work for them and resisted integration to their IT systems. Consequently the functionality of Localeye was enhanced to include details of local community facilities and services in an interactive map. WALGA was required to contract a third party to populate the facilities content after a lack of engagement by Local Governments to assist. The app also had functions added to enable Local Governments to post news and events details to which users would them be able to subscribe. For the past 12 months WALGA has again contracted a third party to update this content on the app from scanning Council websites due to Local Governments claiming to not have the time to enter the information.

Localeye is now at the stage where WALGA will no longer invest in populating Council news and events data. The option remains for Local Governments to access their portal to provide this information however the focus of the app will now revert to the local facilities search functionality. There is the potential for the events function to be opened up to registered community groups to provide content via the portal however this is not in the immediate term planning.

In the near term Localeye and the search functions developed will support a new website to promote the sector that will feature online video content on WA Local Governments produced by WALGA. The new website will present the online content with links to each Local Government and the capacity for Councils to select and stream content from the site to their own websites and facilities. WALGA will

also add to the portal a function by which Councils will be able to select which content they would like to stream - i.e. in effect create their own channel to stream to their website or facilities/waiting areas. As with Localeye the production of the digital content to feature on the website will be at no charge to Local Governments.
