9 MATTERS FOR DECISION

9.1 AVIATION ADVOCACY POSITIONS

WALGA RECOMMENDATION

That State Council endorse two new Advocacy Positions on Aviation as follows:

1. Regional Airports

WALGA supports the sustainable operation of Local Government owned regional airports and advocates for proportionate regulatory frameworks, targeted funding, and operational guidance to ensure safe, efficient, and resilient airport infrastructure and services.

2. Regional and Remote Air Services

WALGA advocates for reliable, affordable, and equitable regional air services, calling for greater oversight of airline pricing practices, including transparent fare structures and equitable access to discounted and lower-cost fares, to mitigate the impacts of limited competition and dynamic pricing on regional residents, businesses, and essential travel. WALGA also promotes the continued viability of essential routes and recognises regional aviation as an essential service supporting community access, workforce mobility, and regional economic development.

EXECUTIVE SUMMARY

- Two new Advocacy Positions are proposed to strengthen WALGA's aviation advocacy framework and to inform WALGA's response to future inquiries and/or consultation relating to aviation.
- The aim of the new positions is to provide clearer and more contemporary guidance on:
 - the sustainability and ongoing viability of Local Government-owned regional airports; and
 - the affordability, reliability and accessibility of regional and remote air services for Western Australian communities.
- The proposed positions will assist WALGA to advocate more effectively on behalf of its Members by:
 - clearly articulating the essential service role of aviation in regional, rural and remote Western Australia;
 - strengthening WALGA's capacity to engage with State and Commonwealth governments on aviation policy and funding; and
 - supporting Local Governments facing regulatory, financial and service-delivery challenges associated with regional aviation.
- The development of the proposed Advocacy Positions has been informed by engagement with a sample of Local Governments, which highlighted shared concerns regarding high regional airfares, service reliability, capacity constraints and the role of aviation in supporting health access, emergency response and regional economic development.

- WALGA currently has two existing aviation Advocacy Positions; however, feedback from Local Governments clarified that the inclusion of additional, targeted policy positions is essential to better reflect contemporary challenges and to strengthen support for Councils.
- The proposed positions build on existing WALGA policy and provide a stronger basis for:
 - sector advocacy;
 - engagement with State Council and Zones to seek feedback; and
 - informing WALGA's potential submission to the Productivity Commission Inquiry into Regional Airfares.

POLICY IMPLICATIONS

The current [WALGA Advocacy Positions](#) relating to Aviation are positions 5.9 Aviation and 5.9.1 Airfare Pricing in Regional Western Australia. The proposed new positions would be in addition to these existing positions.

5.9 Aviation

Position Statement *The Local Government sector supports the Department of Transport's State Aviation Strategy 2020, with more focus required on non-RPT airports to ensure it is representative of all of WA, more focus on general aviation development across WA and noting that the preferred ownership and governance of Local Governments is Council Controlled Organisations. The Local Government sector advocates for a clear position on the economic benefit of airports in regional areas to be included in the future state wide Airports State Planning Policy.*

5.9.1. Airfare Pricing in Regional Western Australia

Position Statement *The Local Government sector supports:*

1. An evidence-based assessment commissioned by the State Government to determine the degree to which market structure and other factors influence the cost of providing air services on each route, the pricing structure offered and the actual prices paid.
2. The State Government providing oversight of airfares ensuring transparency, encouraging partnerships between Local Governments and airline carriers to grow the market and the provision of subsidies in some situations.

BACKGROUND

Aviation plays a critical role in Western Australia, particularly for regional, rural, and remote communities, by providing essential connectivity for access to healthcare, education, employment, and social engagement. Reliable and affordable air services are also vital to regional economic development, workforce mobility, and community resilience, especially where alternative transport options are limited.

WALGA's advocacy on aviation is underpinned by its existing policy framework, which emphasises the need for safe, reliable, and cost-effective air services across regional and remote Western Australia. These policies highlight the critical role of aviation in enabling regional connectivity, supporting service delivery, and contributing to economic development, while recognising the operational and regulatory responsibilities faced by Local Government–managed airports.

WALGA has also contributed to State-level policy development including the State Aviation Strategy 2020. This strategy supports key initiatives including regulating certain routes to support a sustainable service, the Regional Airfare Zone Cap, Regional Airports Development Scheme and regulation of closed charters in some situations. It is anticipated that the Department of Transport and Major Infrastructure will review and refresh the State Aviation Strategy in 2026-27.

At the national level, WALGA engaged in consultation processes leading to the Green and White Papers on Regional Transport and Aviation, representing Local Government perspectives and regional needs.

Two recently initiated inquiries – the Productivity Commission Inquiry into the determinants of regional airfares and the Senate (Rural and Regional Affairs and Transport References Committee) Inquiry into the State of Australia's Aviation Sector and its ability to deliver reliable and affordable services to rural, regional and remote communities – provide important opportunities to review and improve policies supporting regional aviation. Both inquiries have overlapping focus areas, including affordability, government intervention, and impacts on regional communities.

To inform its responses to both inquiries, WALGA has engaged with a sample of Local Governments to understand their experiences, challenges, and priorities for regional air services. This engagement has clarified the needs of Local Governments and communities, forming the basis for developing two proposed new Advocacy Positions to support Members and advocate for improved connectivity, affordability, and service sustainability across regional Western Australia.

NEW ADVOCACY POSITIONS

Regional Airports

Position Statement *WALGA supports the sustainable operation of Local Government owned regional airports and advocates for proportionate regulatory frameworks, targeted funding, and operational guidance to ensure safe, efficient, and resilient airport infrastructure and services.*

•
Background Regional airports are vital for connectivity, economic development, tourism, health access, and emergency response in Western Australia. Local Governments operating regional airports face increasing regulatory and operational pressures, including aviation security requirements, compliance obligations, ageing infrastructure, and limited staffing capacity. Many Council-owned airports cover day-to-day operating costs but lack sufficient capital to fund major infrastructure renewal or security upgrades. Airports that support both community access and FIFO activity can face additional funding constraints despite their ongoing role in servicing regional communities. These challenges highlight the need for regulatory settings and funding arrangements that reflect airport scale, risk profile, and regional operating conditions.

Regional and Remote Air Services

Position Statement *WALGA advocates for reliable, affordable, and equitable regional air services, calling for greater oversight of airline pricing practices, including transparent fare structures and equitable access to discounted and lower-cost fares, to mitigate the impacts of limited competition and dynamic pricing on regional residents, businesses, and essential travel. WALGA also promotes the continued viability of essential routes and recognises regional aviation as an essential service supporting community access, workforce mobility, and regional economic development.*

Background Regional communities rely on air services for essential travel, including access to health care, employment, education, and family connections, particularly where alternative transport options are limited. High airfares, limited availability of lower-cost seats, and opaque pricing structures reduce affordability for residents and businesses, even in markets with more than one airline. Regional air services are also vulnerable to sudden service reductions or route withdrawals, which can isolate communities and disrupt economic and social activity. These challenges underscore the importance of policy settings that support affordability, service continuity, and equitable access.

COMMENT

Engagement with a sample of Local Governments operating airports with Regular Passenger Transport (RPT) services highlighted operational, financial, and service delivery issues affecting both Council-owned airports and regional air services.

Key matters raised by Councils include:

- Airline pricing and equitable access: Complex, opaque, and highly variable fare structures; limited availability of lower-cost seats; competition does not always deliver affordable or equitable outcomes.
- Aviation security requirements: Standards designed for larger airports impose significant operational and financial burdens, with outdated equipment, regulatory ambiguities, and high upgrade costs creating compliance challenges.
- Funding and resource constraints: Many Councils operate airports with limited staff and capital; while day-to-day operating costs may be covered, major infrastructure renewal or expansion and security upgrades are often unfunded.
- Service continuity and reliability: Regional air services are fragile, with sudden route reductions or withdrawals impacting essential travel, community connectivity, and local economies.
- Coordination across governments and industry: Fragmented policy, regulatory, and funding arrangements limit Local Governments' ability to respond quickly to changes, highlighting the need for improved collaboration.
- Regional aviation as an essential service: Airports and air services underpin health access, emergency response, tourism, economic development, and social cohesion, demonstrating their broader value beyond transport alone.

Based on these issues and priorities identified through Local Government engagement, WALGA has developed the two proposed Advocacy Positions above on aviation – one focusing on regional airports and the other on regional and remote air services – to address

the challenges of affordability, accessibility, operational sustainability, and service continuity for regional communities.

GASCOYNE COUNTRY ZONE

That the Gascoyne Country Zone supports the WALGA recommendation for State Council Agenda item 9.1 as contained in the State Council Agenda and as provided above with the addition of point 3:

3. Regional airfares be capped with an affordable pricing structure that is equitable across all Regions.

SECRETARIAT COMMENT

WALGA notes the Gascoyne Country Zone’s recommendation regarding capped regional airfares. This proposal is most closely aligned with State, rather than National aviation policy, and raises complex policy and definition considerations that would require further investigation and engagement with relevant stakeholders and governments. WALGA will consider this matter in future advocacy and policy development work.

GOLDFIELDS ESPERANCE COUNTRY ZONE

That the GVROC support the two new WALGA Advocacy Positions on Aviation and also ask WALGA to consider its comments regarding this matter as listed:

- The increase in industry activity, in particular the mining industry with FIFO requirements, in regional and remote areas, places increased impacts on LGAs in provision of aviation services and facilities that normally may not be required or needed e.g. Shire of Coolgardie ramped up services and facilities for its airstrip in Kambalda that had previously not been utilised for some time. This industry impact needs to be accounted for when looking at the sustainability of regionally owned airports and the contributions that industry may need to make.
- Further to the above there also should be a better support mechanism provided to small regional LGAs to assist in the administration and management of aviation facilities so they can meet the requirements placed on them e.g. environmental, social and governance regulations.
- The current advocacy positions recommended are quite broad in description and the Shire of Esperance thought that they could be a bit more specific and detailed on certain requirements.

- Shire of Esperance was also recently advised by Minister Dawson that funding for airports is not a State Government responsibility but a Federal Government responsibility and LGAs should be going to the Federal Government with requests. The GVROC disagreed with this position and believes the State Government should provide more funding to upgrade airport facilities in regional WA and would like this to be advocated by WALGA.
- There are many smaller airstrips, some privately owned, around the vast area of the Goldfields Esperance region that are used by the Royal Flying Doctor Service, however many do not meet the requirements, and this poses a danger to the RFDS and regional communities in emergency situations. The GVROC would like WALGA to advocate for more funding to ensure region and remote RFDS used airstrips are kept maintained and up to standard to ensure adequate emergency services are in place when situations arise.

SECRETARIAT COMMENT

- WALGA notes the impacts of increased industry activity, particularly FIFO operations, on regional airport infrastructure and costs for Local Governments. The Regional Airports Advocacy Position supports the sustainable operation of council-owned airports and targeted funding, providing a framework for advocating for appropriate contributions, including from industry where relevant.
- WALGA notes the challenges faced by smaller regional Local Governments in managing aviation facilities. The Regional Airports advocacy position calls for “proportionate regulatory frameworks, targeted funding, and operational guidance” to help councils meet safety, governance, and regulatory requirements, addressing capacity and resourcing constraints.
- WALGA notes the feedback and advises that the Advocacy Positions are intentionally high level, with detailed priorities to be developed through WALGA’s advocacy planning and submissions processes.
- The Commonwealth has responsibility for and control over interstate and international aviation under s51(i) of the Constitution and includes matters “inseparably connected” to interstate aviation such as safety. Other aspects of intrastate aviation are the responsibility of the States and Territories. Given the interrelationships, WALGA considers airport funding to be the responsibility of both the State and Federal Governments. WALGA will continue to advocate to both levels of government to support regional airport infrastructure and aviation services.
- WALGA notes the concerns regarding suitability of airstrips to meet evolving needs of RFDS aircraft. Further work and engagement with relevant stakeholders is needed to guide advocacy and funding approaches.

PILBARA COUNTRY ZONE

That the Pilbara Country Zone supports the WALGA recommendation for State Council Agenda item 9.1 as contained in the State Council Agenda subject to the amendment below:

To add the following words to position statement 5.9.1 part 1:

The Local Government sector supports:

1. An evidence-based assessment commissioned by the State Government to determine the degree to which market structure Commercial agreements and other factors influence the cost of providing air services on each route, the pricing structure offered and the actual prices paid.

SECRETARIAT COMMENT

The Zone proposes an amendment to the existing policy position, 5.9.1. (Airfare Pricing in Regional Western Australia) to include "commercial agreements." The intent is to highlight the impact of block bookings for FIFO staff on the availability of seats and the negative impact of this on availability and price of travel to some regional destinations. The existing advocacy position is not being reviewed within this draft resolution.

Block booking flights with high load factors negatively impacts seat availability and price for travellers. In response, the proposed advocacy position on Regional and Remote Air Services has been amended to reference the need for adequate capacity net of contracted (FIFO) seats.

BACKGROUND

An item was presented to State Council at the September 2025 meeting detailing proposed amendments to the Corporate Governance Charter, Code of Conduct, State Council Standing Orders and AGM Standing Orders. The amendments were developed as part of a comprehensive review of the Charter (and related supporting documents) undertaken by the administration. At that September meeting, State Council resolved to defer the item.

Since then, a facilitated workshop was held with State Council to consider the proposed amendments in detail. Whilst the workshop generated much discussion on proposed amendments to the Charter, there was general consensus amongst participants as to the proposed amendments to the AGM Standing Orders.

COMMENT

The key amendment proposed to the AGM Standing Orders is to remove the requirement to “switch off” mobile phones during General Meetings (section 12.5). This is a necessary change as WALGA now uses an app-based voting system at Annual General Meetings.

Last year, the membership resolved at the AGM to adopt the Standing Orders with the exception of section 12.5 to allow for the use of mobile phones during the meeting. To ensure the Standing Orders can be adopted in full this year, it is proposed that section 12.5 be removed entirely.

Other proposed amendments are relatively minor, including:

- General tidy up of definitions section, including incorporating parts that were previously within the body of the Standing Orders that are better suited to being in the definition section.
- Consistent use and capitalisation of defined terms.

The Selection Committee is a Committee of State Council established to oversee the selection process for Local Government vacancies on boards and committees.

The Committee conducts a merit-based and transparent assessment process encompassing the principle of “best person for the job”. Upon completion of the assessment of nominations for vacancies, the Selection Committee either endorses preferred candidates for appointment (under delegated authority) or makes advisory recommendations to State Council for ratification of preferred candidates.

The State Road Funds to Local Government Advisory Committee (SAC) is established by the State Road Funds to Local Government Agreement. SAC is responsible for overseeing, monitoring and endorsing to the Minister for Transport, via the Managing Director Main Roads, the allocation of State funds under the Agreement. The membership of SAC includes the Managing Director of Main Roads, four Main Roads officers, the WALGA President (or their proxy), the WALGA CEO (or their nominee) and three other representatives as nominated by WALGA.

The terms for the three current representatives nominated by WALGA have expired and new members need to be appointed for the next SAC meeting on 4 May.

The four Local Government SAC members, including the WALGA President, will be balanced across the Metropolitan and Country constituency.

COMMENT

If the usual Selection Committee process were to be followed, State Council would endorse the Selection Committee recommendation for appointment at the next State Council meeting on 6 May. As this falls after the SAC meeting date, delegated authority is requested from State Council to expediate the process.

The expedited process, if supported, would have the following timeline:

- Delegated authority from State Council granted for the Selection Committee to undertake the selection process – 4 March State Council meeting.
- Vacant positions advertised for a period of at least four weeks.
- Nominations close – 3 April.
- Selection Committee considers nominations and decides preferred candidates – meeting in the week commencing 13 April.
- Appointments confirmed to SAC – by 20 April.
- First SAC meeting for new members – 4 May.

1. Matters for State Council Decision

Submissions to the Economic Regulation Authority concerning the Framework and Approach to the next Western Power Access Arrangement (AA6); and to the Senate Inquiry into the Aviation Sector and its ability to deliver reliable and affordable services to rural, regional and remote communities were developed and subsequently considered by State Council by way of Flying Agenda.

The Policy Team considered new and revised aviation Advocacy Positions in relation to Regional Airports and Regional and Remote Air Services, which are included in this Agenda for endorsement at [item 91](#).

2. Matters for State Council Noting

The Policy Team noted an update on the Active Transport Advocacy Plan.

Matters referred from Zones considered were:

- International Driver Safety – which was recommended to be referred to the Road Safety Commission;
- State Road Funds to Local Government Advisory Committee membership was noted and will be considered by State Council as part of the broader Corporate Governance Charter review;
- Advocate for the Auditor General to undertake a performance audit of the Disaster Recovery Funding Arrangements Western Australia (DRFAWA) which was supported as an action; and
- Advocate for Local Governments to manage access on Local Government Roads for Restricted Access Vehicles. This would have very large resource implications for Local Governments to establish and manage such a system, as well as requiring extensive legislative and regulatory changes. Short term work is focused on recent changes to access conditions implemented by Main Roads without any consultation. The broader policy implications will be considered following this.

WALGA's submission primarily focussed on the significant implications for Local Governments' management of Volunteer Bush Fire Brigades (VBFBs) that arise from the inclusion of volunteers as workers under the WHS Act.

The submission made three recommendations:

1. Providing greater legislative clarity on PCBU responsibilities during bushfire response.
2. The implementation of a contemporary legislative and policy framework for bushfire management that addresses WHS concerns for VBFBs and provides certainty on what "reasonably practicable" means under the WHS Act, as applied to VBFBs, and how it should be achieved.
3. Increased funding and support for VBFBs through the LGGs and for the CESM program.

More generally, the submission further recommended the provision of specific, practical guidance for Local Governments to clarify Council Members' protections and duties under the WHS Act and support a consistent approach across the sector.

The submission was endorsed by the Governance and People and Place Policy Teams at a joint meeting on 1 December 2025 and endorsed by State Council via Flying Minute on 10 December 2025. The submission was lodged with WorkSafe on 12 December 2025.

The submission was endorsed by State Council via Flying Minute and submitted on 14 November 2025.

3. ENVIRONMENT POLICY TEAM MATTERS

Transit Oriented Development Advocacy Position

At the December meeting, State Council endorsed a motion requesting WALGA prepare an Advocacy Position regarding the transport and planning principals required to ensure quality outcomes in the Station Precinct Improvement Plans and Schemes.

During the January meeting, the Environment Policy Team was provided an update on the process and timeline of the development of a Transit Oriented Development Advocacy Position. To address concerns of the Policy Team regarding delayed advocacy as a result of the creation and endorsement of a new Advocacy Position, WALGA will commence consultation on a new position with an initial focus on immediately impacted Local Governments while continuing to make representations to Government under cover of existing positions.

Climate Change Advocacy Position Review

The first stage of the Inquiry is seeking feedback on the Terms of Reference. WALGA developed a short submission, based on the [715 Product Stewardship Advocacy Position](#) and previous submissions on tyre Product Stewardship.

3. MUNICIPAL WASTE ADVISORY COUNCIL MATTERS

BACKGROUND

The Federal Assistant Treasurer recently called for submissions for the 2026-27 Budget.

Each year, ALGA prepares a submission on behalf of the Local Government sector nationally. The 2026-27 ALGA submission requests funding for a range of initiatives across the following key themes:

- Financial sustainability;
- Housing infrastructure;
- Community infrastructure;
- Safer roads;
- Emergency Management; and
- Climate adaptation.

A copy of ALGA's 2026-27 Budget Submission is attached.

WALGA's submission (attached) supports ALGA's, and seeks a commitment to address additional issues of particular importance for WA Local Governments, including:

- Additional ongoing, formula-based targeted funding streams for Local Governments to provide certainty and enable effective planning for community needs.
- A funding contribution to match the Western Australian Government commitment to apply proven road safety countermeasures on 1,474km of regional roads, representing the prioritised sections of the proposed Regional Road Safety Program.
- A dedicated Coastal Hazard Adaptation program.
- Funding support to address the gaps in the Long-Term Cycle Network.
- Dedicated funding for Councils across Australia to improve mitigation and resilience and build their capacity and capability to respond to emergencies in our communities.
- Support for rural and remote Local Governments in Western Australia to cover the costs of providing essential primary healthcare services, until long-term funding and workforce solutions are in place.
- Extension and expansion of the Mobile Network Hardening Program to ensure reliable and resilient telecommunications in peri-urban, rural, regional and remote areas.
- Funding for Stage 2 of the Wheatbelt Secondary Freight Routes.

- WALGA has developed a short submission, aligned to the [Advocacy Position 7.15 Product Stewardship](#) and previous WALGA submissions on tyre product stewardship.
- The Submission was endorsed by the Municipal Waste Advisory Council (MWAC) under delegated authority from State Council on 10 December 2025 and lodged with the Committee on 19 December 2025.

The submission aligns with the current WALGA [Advocacy Position 7.15 Product Stewardship](#).

7.15 Product Stewardship

- Position Statement
1. Industry should take responsibility (physical and/or financial) for the waste that it generates through the entire life cycle of the products it produces through the implementation of effective product stewardship. Without effective Product Stewardship, there will be increasing costs for the community, resource recovery targets will be difficult to reach and a transition to a circular economy is unlikely.
 2. Effective Product Stewardship is characterised by:
 - a. Producers and importers taking responsibility for post consumption product impacts.
 - b. Schemes covering the entire cost of product recycling or recovery, including transport.
 - c. Leveraging existing Schemes and collection locations.
 - d. Being easy and convenient for the community to access.
 - e. Having equitable national coverage and access for all, including regional and remote locations.
 - f. Being evidence based.

- g. Consistent regulation and implementation across Australia using national Product Stewardship legislation.
 - h. Timely action and industry cooperation during Scheme development and implementation.
 - i. Being demand based and aiming to recover the maximum amount of material, rather than being limited by targets.
 - j. No additional cost to consumers when the product is disposed of post consumption.
3. Local Government calls on the Commonwealth Government to implement effective Product Stewardship schemes for all products that drive environmentally and socially sustainable outcomes through the design, manufacture and distribution of products that can be more easily reused, repaired, recovered or recycled.
 4. If national action is not progressed within a reasonable timeframe, or in a way that meets the needs of the Western Australian community, then Local Government supports a State based approach to Product Stewardship.

BACKGROUND

The Parliament of Australia's Standing Committee on Industry, Innovation and Science has commenced an [Inquiry](#) into the current state of the Australian tyre industry and any challenges and opportunities for the industry within the context of a circular economy.

The first stage of the Inquiry is requesting feedback on the Terms of Reference for the Inquiry. Following this consultation, the Standing Committee will confirm the Terms of Reference and commence development of an inquiry report and recommendations.

The proposed Terms of Reference are:

1. Reviewing tyre manufacturing, distribution, importation, and retail trends.
2. Investigating current practices in tyre reuse, retreading, recycling, and resource recovery, including reviewing federal, state, and local regulations governing tyre production, disposal, and recycling.
3. Exploring technological advancements in tyre design, recycling processes, and alternative materials.
4. Identifying opportunities to develop high-value uses for waste tyres and tyre-derived materials, including applications in construction, manufacturing, and other commercial sectors.
5. Evaluating the effectiveness of the existing circular economy models and identifying opportunities for research and development to support improved sustainable practices.
6. Considering the role of commercially viable product stewardship schemes and whether these should be made mandatory, and identifying infrastructure gaps in collection, processing, and recycling facilities.
7. Investigating environmental, community, and health and safety concerns related to tyre waste and recycling operations.

COMMENT

In managing end of life tyres, waste providers and Local Governments are constrained by high collection costs, limited recycling options and transport costs to processors, along

with the cost to recycle the material. Lack of widespread, accessible and affordable disposal options for community members leads to activities such as stockpiling and illegal dumping, creating environmental and health risks and amenity issues within communities.

WALGA [Advocacy Position 7.15 Product Stewardship](#) states effective product stewardship schemes should cover the entire cost of collection and recycling, have equitable coverage, including regional and remote locations, and impose no additional costs on consumers when the product is disposed of post consumption.

The submission focuses on the importance of mandatory product stewardship and identifying the issues Local Governments continue to experience in relation to tyre management. The Submission was endorsed by the Municipal Waste Advisory Council (MWAC) under delegated authority from State Council on 10 December 2025 and lodged with the Committee on 19 December 2025.

WALGA will undertake further engagement with the sector when the next stage of the Inquiry is released.

11.3 SUBMISSION ON THE STATE HAZARD PLAN HAZMAT ANNEX B SPACE RE-ENTRY DEBRIS (SPRED)

EXECUTIVE SUMMARY

- The WA Police Force has completed a five yearly review of the State Hazard Plan HAZMAT Annex B Space Re-entry Debris (SPRED).
- WALGA submitted officer-level feedback on the proposed amendments on 22 December 2025, utilising WALGA's established Advocacy Positions and priorities outlined in State Council–endorsed documents, including The West at Its Best.
- WALGA's recommendations focus on clarifying roles and responsibilities, ensuring Local Governments are not assigned Hazard Management Agency functions, and reinforcing the need for strong State-level responsibility and coordination.

BACKGROUND

The WA Police Force has completed a five yearly review of the State Hazard Plan HAZMAT Annex B Space Re-entry Debris (SPRED). Initial review and consultation occurred between January and August 2025 with the WA Space Debris Emergency Response Team, and representatives from the National Emergency Management Agency, Australian Space Agency, State Emergency Management Policy Branch, Department of Fire and Emergency Services (Recovery), Department of Water and Environmental Regulation, Department of Health (Radiation Health), and the Department of Communities.

A 12-week broad consultation with the Local Government sector occurred between October and December 2025. The sector was notified via the Local Government Emergency Management e-network and e-newsletter. WALGA submitted officer-level feedback on the proposed amendments on 22 December 2025 via CEO Nick Sloan, guided by existing WALGA Advocacy Positions and budget submissions.

Stakeholder feedback is currently being considered, for which WALGA has received commentary against submission points, noting their acknowledgement and where relevant, their resulting amendments to the Plan.

COMMENT

The Annex outlines activities in line with the State Emergency Management Framework. There was minor reference to Local Government, however, WALGA still found value in reviewing to ensure consistency of responsibilities and providing Local Government representation.

WALGA's comments on the State Hazard Plan – HAZMAT Annex B Space Re-entry Debris (SPRED) draw on and align to previous WALGA State Council endorsed submissions and Advocacy Positions. WALGA's recommendations included to make clear the primary role of WA Police in preparedness and response to SPRED and remove any references to Local Government responsibility to plan for SPRED. It also recommended ensuring inclusion of Local Government in local level incident response structures, such as the Incident Support Group (ISG). The final recommendation was to ensure the SPRED is fully aligned with upcoming revisions to the State Emergency Management Framework.

11.4 COMMUNITY SPORTING AND RECREATION FACILITIES FUND AND COMMUNITY NIGHT LIGHTS PROGRAM FUNDING PAUSE

EXECUTIVE SUMMARY

- The Community Sporting and Recreation Facilities Fund (CSRFF) and Club Night Lights Program (CNLP) are critical funding streams for Local Government and community sporting organisations investment in sports and recreation infrastructure.
- The 2025-26 budget committed \$88.8 million to the two programs over four years.
- In late 2025 the Department of Creative Industries, Tourism and Sport (CITS) informed WALGA that the CSRFF and CNLP funding rounds have been temporarily paused, including remaining funding allocations for 2025-26 and that these programs are being reviewed.
- WALGA understands that funding for these programs is being paused to focus on delivery of the State Government's 2025 sport and recreation election commitments.
- The Local Government sector has not been formally advised of the pausing of these programs, which will have a significant impact on the delivery of community infrastructure projects.
- The WALGA President wrote to the Minister for Sport and Recreation in December 2025 and is awaiting a response (see attachment) to stress the importance of these programs and seeking urgent advice regarding the Government's intention for the remaining 2025-26 funding allocations.
- WALGA is urgently seeking a meeting with the Director General of CITS.
- WALGA will continue to advocate for the ongoing, sustainable funding of the CSRFF and CNLP, separate to election commitments.
- Updates will be provided to State Council and Members as information becomes available.

POLICY IMPLICATIONS

This Item for Noting aligns to WALGA [Advocacy Position 3.7 Community Infrastructure](#):

Local Governments own, lease, and maintain vital community infrastructure across Western Australia that delivers essential benefits to local communities. Local Governments face significant funding pressures to ensure this infrastructure is effectively planned, developed, maintained, and enhanced to meet evolving community needs and population growth.

1. *WALGA calls on the Australian Government to provide \$500 million per annum for community infrastructure through a national formula based, targeted Local Government funding program.*
2. *WALGA calls on the State Government to:*
 - i. *Provide \$60 million per annum for the Community Sporting and Recreation Facilities Fund, separate to the PlayOn WA 2030 Funding commitments.*
 - ii. *Provide \$60 million per annum for community arts and cultural infrastructure,*
 - iii. *Provide funding for retrofitting accessible design features to community infrastructure,*

- iv. Align all community infrastructure funding with existing State co-contribution of at least two-thirds.*

BACKGROUND

The CSRFF is a well-established State Government funding program that provides financial assistance to Local Governments and community groups to develop infrastructure for sport and recreation. The CNLP provides financial assistance for sports floodlighting infrastructure. Both programs are well utilised by the sector with funding allocations oversubscribed in recent years.

The funding levels of the CSRFF is an existing priority for WALGA, included in the [WALGA 2026-27 State Budget Submission](#) and [State Election priorities](#), and aligned to the Advocacy Position endorsed by State Council in September 2025 (3.7 Community Infrastructure, as included above). [PlayOn WA](#) is an overarching initiative announced in 2025 to guide State Government investment in community sport and recreation infrastructure. The initiative aims to deliver "2030 by 2030": 2,030 community sport and recreation infrastructure items by 2030 in partnership with Local Governments, clubs and community groups.

In November 2025, WALGA became aware via Members that advertised funding rounds for CSRFF and CNLP had not opened. CITS advised that funding rounds for 2025-26 had been paused while a review of the programs was undertaken. Further information on the impact on current and future rounds was requested but not provided. WALGA understands that funding for these programs is being paused to focus on delivery of the State Government's 2025 sport and recreation election commitments.

On 17 December 2025, WALGA wrote to the Minister for Sport and Recreation, the Hon Rita Safiotti, raising sector concerns and seeking urgent advice on the Government's intentions regarding the CSRFF and CNLP (see attachment) and requesting to meet to discuss the strategic direction of sport and recreation infrastructure funding. A response to this letter is yet to be received. Concurrently, Lotterywest is undertaking a grant strategy review on the current state of Lotterywest grant-making and possibilities for its future state. Feedback from Local Governments indicates that this is impacting current grant applications. WALGA has been engaged in the consultation process.

WALGA emphasised the importance of dedicated funding for community sports and recreation infrastructure as part of the submission and Local Government joint hearing to the Inquiry into Community Use of WA Public School Facilities by the Education and Health Standing Committee in late 2025.

COMMENT

The CSRFF and CNLP are critical programs for investment in community infrastructure, based on identified need at the local level. WALGA is advocating strongly for the retention of, and increased funding for these programs, separate to the funding of election commitments and PlayOn WA.

WALGA is urgently seeking clarity and further information on the Government's intentions on this matter. Updates will be provided to State Council and Members as information becomes available.

The following outlines the activities of the Advocacy Portfolio since the December 2025 State Council meeting.

1. ASSOCIATION GOVERNANCE

Zones Delegates and State Councillors

Following the 2025 Local Government Elections, induction sessions have been provided for all new Zone Delegates, State Councillors and Deputy State Councillors to familiarise them with their role and responsibilities. A Zone Chair induction is currently being planned, with invitations to be sent shortly.

Local Government Honours Program

Nominations for the 2026 Honours Program has now launched. WALGA's Local Government Honours Program enables significant public recognition and celebration of the outstanding achievements and lasting contributions made by Elected Members and employees to their respective Councils, the Local Government sector and the Association. The Honours Panel, a delegated Committee of State Council, is responsible for the format, criteria and judging of the Honours awards.

The 2026 Program includes five award categories, all open to both Elected Members and Officers including the Local Government Medal, Life Membership, the Eminent Service Award, Merit Award and Young Achievers Award.

2. MARKETING

WALGA Training Campaigns

Multiple marketing campaigns ran at the end of 2025 and into 2026 to raise awareness of the below training courses:

- Diploma of Local Government – Elected Members
- Nationally Recognised Training for Officers


With the Certificate III and Diploma running concurrently in 2026, messaging shifted to a training pathway approach, positioning training as part of a broader professional journey.

This approach performed well with a high level of enquiries and conversions to courses booked.

Website

Q2 2025/26 recorded over 101,000 sessions and 72,439 active users (a 30% year-on-year increase in sessions), with a 2% uplift from Q1 2025/26. The boost in traffic was generated from December media releases and interest in the showcase in Pixels competition.

- Copywriting of WALGA's December Western Councillor Magazine.


4. MEDIA

There were 486 mentions of WALGA and President Karen Chappel between Saturday, 1 November 2025 - Tuesday, 20 January 2026 (80 days).

This is a decrease from 1,242 in the previous reporting period (85 days), which can be attributed to the previous period including WALGA's Local Government Convention, Local

Government Elections and the introduction of the Local Government Amendment (Rating of Certain Mining Licences) Bill 2025 to State Parliament, which generated significant media coverage.



2025 New Elected Member Seminar

The New Elected Member Seminar provided an important induction opportunity for newly elected Councillors, supporting them to understanding their governance responsibilities and the broader Local Government landscape.

The 2025 seminar attracted 70 in-person attendees and 50 virtual participants, from across the state. Feedback highlighted the practical format, clarity of content, and highly regarded speakers.

2025 Showcase in Pixels

The 2025 Showcase in Pixels competition attracted more than 300 entries, giving judges the challenging task of shortlisting finalists and selecting winners across six categories, with the People's Choice Award voted by the public. The display generated strong community engagement and celebrated the creativity of residents across Western Australia.

2025 WALGA Wrap

Over 200 guests including key stakeholders across Government, Industry and WALGAs Preferred Program attended the WALGA Wrap to celebrate the achievements of 2025.

2026 Aboriginal Engagement Forum

12.1.2 REPORT ON KEY ACTIVITIES, INFRASTRUCTURE PORTFOLIO

The following outlines the activities of the Infrastructure Portfolio since the last State Council meeting.

1. ROADS

Local Government Transport and Roads Research and Innovation Program (LGTRRIP)

The development of a road safety rating tool for intersections is progressing, while work on the Crumb Rubber in Asphalts Guideline is nearing completion. Work on a guideline for use of Marginal Materials will commence soon.

Road Rail Interface Agreements

Following an internal error on the part of Arc Infrastructure, model *pro forma* Interface Agreement templates between Local Governments and Arc Infrastructure will be redistributed by Arc Infrastructure to Local Governments in the South West, Goldfields, and Great Southern regions. Agreements will also be sent to Local Governments in the Mid West and Wheatbelt regions as part of this re-release. A memorandum outlining what has changed between the old and new agreements, the main issues of contention, their resolution, and other key updates was provided to all Local Governments hosting Arc Infrastructure operated rail in July 2025.

Rail Interface Agreements have been required since 2010 with the details now set out under the *Rail Safety National Law (WA) 2024*.

Guidelines and Specifications for Residential Crossovers

WALGA is currently reviewing the practicality and effectiveness of the Residential Crossover Guidelines and Specifications to ensure they continue to meet the needs of Local Governments. A survey was undertaken to gather feedback from Local Governments on how the document is being applied, which sections are most useful, and where improvements may be required.

The survey responses have now been reviewed, and the next phase of work is progressing, including further engagement to inform potential updates to the document.

2. ROAD FUNDING

State Road Funds to Local Government Advisory Committee (SAC)

To reduce the impact of project delays on funding carried forward, a rapid evaluation of 68 “shovel ready” project proposals from Local Governments with a grant value of over \$30 million was undertaken with Main Roads WA and a series of recommendations made.

The SAC met in December and approved:

1. 2025/26 funding for 27 “shovel ready” projects from non-metropolitan regions with a grant value of \$10.1 million to be funded from future Metro RRG funding allocations.
2. 2025/26 funding for 21 rehabilitation projects in the metropolitan region with a grant value of \$5 million to be funded from future Metro RRG funding allocations.
3. changes to the SAC Procedures to provide guidance on Regional Road Group Policies.

Key issues for discussion and further action were:

1. Overcoming challenges in delivering an Aboriginal employment commitment project;
2. Response to the Auditor General Report on regional Local Government road maintenance;
3. Timetable for BlackSpot program to be completed and communicated to Local Governments;
4. Support from Main Roads WA for DRFA WA assessments on local roads;
5. Changes made to the Restricted Access Vehicle (RAV) condition of access requiring Local Governments to provide a letter of support for transport tasks.

Regional Road Safety Program

Working in partnership with the RAC and Main Roads WA, WALGA provided guidance to updating the original 2022 Business Case for investment in regional road safety improvements. The update reflects road improvements recently completed, revised cross-sections, construction cost increases and benefits from reduced shoulder maintenance costs. Main Roads WA have provided the updated case to Infrastructure Australia.

Responses from the 27 Local Governments invited to deliver projects funded under Tranche 2 of the program will be assessed in February, with a proposed program to be finalised as soon as possible.

Changes to the MOU between Main Roads WA and participating Local Governments were negotiated following feedback from LGIS regarding proposed provisions in relation to liability and insurance.

Multi-Criteria Assessment (MCA) Model Revisions

WALGA continues to work with the Regional Road Groups to better align the MCA models used by Regional Road Groups to prioritise projects for Road Project Grant funding with the provisions outlined in the procedures document of the State Road Funds to Local Government Agreement (Agreement). The proposed changes to the MCA models reflect the new focus areas of the Agreement, while still allowing for flexibility to recognise the significant differences between regions. All the Regional Road Groups have commenced the MCA revision process, with the process in the Gascoyne, Great Southern, Kimberley, and South-West region now complete. Significant progress has been made in each of the other regions.

3. TRANSPORT

Active Transport and Micromobility Advocacy Plan

Development of the Active Transport Advocacy Plan is underway, with a number of initial advocacy actions identified to support the implementation of the endorsed policy positions. These actions include a range of advocacy and engagement activities, with indicative timeframes and target audiences identified.

Delivery of the advocacy actions will require both internal and external collaboration, with stakeholder engagement undertaken as appropriate to the purpose of each action.

4. ASSET MANAGEMENT

Road Assets and Expenditure Report Project

In a significant shift, WALGA's Strategic Executive Team was presented with and approved a proposal to engage the internal WALGA Business Intelligence & Analytics team to undertake the work to modernise the architecture and processes used to manage data and generate the Road Assets and Expenditure Report, rather than moving forward with an external consultant. The work undertaken by Tango IT to detail the current processes used to develop the Road Asset and Expenditure Report and a future state will still be used as a basis for completing this work. The project will include the development of a database, reporting interface, and dashboard and will commence in early 2026.

Review of the WALGA Road Visual Condition Assessment Manual

The revisions of the WALGA Road Visual Condition Manual, originally published in 2016, are now almost complete, with a final draft version currently circulating with key stakeholders for a final review. This manual provides important support to Local Government road managers and provides the framework for being able to understand the condition of the road network statewide. This is aligned with recommendations in the Auditor General's report, *Maintaining Regional Local Roads*.

5. UTILITIES

Western Power

WALGA met with the Economic Regulation Authority and Western Power to discuss progress on the undertakings within the current Access Arrangement (AA5) and the issues for consideration in the next Arrangement (AA6).

The next meeting with the Western Power Customer Connections team is scheduled for 9 February. An agenda has been developed, and a representative group of metropolitan Local Governments will be providing feedback on the effectiveness of the changes that were agreed.

ERA Framework and Approach

As a State-owned monopoly, Western Power is regulated by the Economic Regulation Authority (ERA) primarily through a mechanism called an Access Arrangement, which sets out Western Power's undertakings, describes the terms and conditions of access to the Western Power network, and stipulates the prices it can charge for specific services. The current iteration, AA5, runs until 2027. Work has commenced to review the current Arrangement and the framework and approach for the next Arrangement (AA6). WALGA prepared a discussion paper for Local Government input and will provide a formal submission to the ERA by the deadline of 6 February 2026.

Streetlighting

WALGA continued to support Western Power and their consultants in their initial engagement with Local Governments through a survey of streetlighting requirements, expectations and issues. Around half of the Local Governments in the area served by Western Power responded to the survey. In addition to providing feedback, most indicated an interest in further providing more detailed input to the streetlight asset management strategy.

Telecommunications

A range of risk, liability and operational constraints need to be resolved in order to progress a pilot deployment of backup generators to support telecommunications during power failures. WALGA is meeting regularly with Telstra, the Department of Primary Industry and Regional Development and other stakeholders seeking to define an operational model and agreements to put this in place.

6. ROAD SAFETY

RoadWise Councils

As of 1 January 2026, there were 75 Local Governments registered as a RoadWise Council, spread across all 10 Regional Road Group regions. During the October–December 2025 quarter, 65 RoadWise Councils implemented 257 local road safety activities, supported by WALGA's team of road safety staff.

RoadWise Recognised

The RoadWise Recognised Advisory Committee last met in November 2025 and endorsed the allocation of 3,441 Points to the 73 RoadWise Councils who collectively recorded road safety actions during the July-September quarter. Points are allocated for each road safety activity or intervention undertaken as per the RoadWise Framework. Points are based on the effectiveness, longevity and scale of the road safety activity and considers the capacity of the RoadWise Council.

12.1.3 REPORT ON KEY ACTIVITIES, MEMBER SERVICES PORTFOLIO

The following outlines the activities of the Member Services Portfolio since the December 2025 State Council meeting.

1. COMMERCIAL

The Commercial Development team has completed Tenders contracting 145 Preferred Suppliers to the Preferred Supplier Program (PSP). This includes 34 new Contracts for Aboriginal businesses resulting from a special project to enhance the presence of Aboriginal businesses within the PSP. New PSP development and enhancements are progressing in the areas of ICT (ERP systems), Sustainable Energy Infrastructure, Building Inspection Services, Project and Operations Management.

The Commercial Management team has commenced onboarding new Preferred Suppliers following the recent PSP and Aboriginal business tender processes. With 145 suppliers successfully tendering, onboarding is expected to continue through to late February or early March. The reporting period for Quarter 2 PSP engagement opened to Preferred Suppliers on 5 January 2026, with Contract Managers continuing to monitor reporting compliance.

ARENA/EV Project

The ARENA project continues to progress through a reporting and knowledge-sharing phase, with intended closure by 30 June.

Artificial Intelligence (AI) Project

The Sector and WALGA (internal) AI readiness assessment has been completed. Work on potential initiatives related to AI and cybersecurity for Members is ongoing.

2. EMPLOYEE RELATIONS

WALGA ER continues to represent the sector in a number of applications in the WA Industrial Relations Commission (WAIRC), including:

- Applications CICS 5, 8 and 9 of 2023 - Union demarcation dispute and associated applications:
 - CICS 5, 8 and 9 of 2023 is an application by the Western Australian Municipal, Administrative, Clerical and Services Union of Employees (WASU), for coverage

- of Local Government employees to the exclusion of the Construction, Forestry, Mining and Energy Union of Workers (CFMEUW) (the Demarcation claim).
- The Local Government, Racing and Cemeteries Employees Union (LGRCEU) and WALGA are intervenors.
- The Demarcation claim was heard by the WAIRC, sitting as the Commission in Court Session (CICS), over 41 days in July and October of 2024 and October and November 2025.
- During the course of the Demarcation claim the CFMEUW made various applications for production of documents and to dismiss the Demarcation claim which caused significant delays and costs. Four key applications were:
 - The first application was to dismiss the matter, which the Commission rejected and dismissed.
 - The second application was for discovery of documents from WALGA and the WASU, which the Commission ordered and WALGA and WASU complied with. WALGA and WASU have claimed privilege over these documents (Privilege Claim).
 - The third application was for discovery of documents from WALGA, WASU and the LGRCEU. In response the WASU, LGRCEU and WALGA applied to dismiss the CFMEUW's second application for production of documents. This was dismissed by the CICS on 26 March 2025 (Dismissal Decision)
 - The CFMEUW lodged an appeal to the Industrial Appeal Court (IAC) against the Dismissal Decision (IAC 2/2025).
- The Privilege Claim was heard by the CICS as an interlocutory matter on 28 May 2025. The CICS issued a decision on 11 July 2025, upholding the claims of legal professional privilege and accordingly no orders for production of these documents will occur.
- Following the Privilege decision the CFMEUW withdrew its appeal to the Industrial Appeal Court against the CICS decision to dismiss the CFMEUW's Second application for production of documents (IAC 2/2025).
 - The CICS has reserved its decision in the Demarcation claim. Given the length of the hearing, the number of witnesses and amount of evidence produced during the hearing it is not possible to predict when the Demarcation claim decision will be handed down.
- Applications APPL 3 and 4 of 2023 – concerned award variations sort by the WASU to the Local Government Officers' (WA) Award 2021 (LGO Award) and the Municipal Employees Award (WA) 2021 (ME Award) as follows:
 - increase casual loading from 20% to 25%;
 - conversion of casual employees who have worked for more than 12 months to permanent employment;
 - increased regional redundancy entitlements for employees working outside Perth;
 - an additional week of entitlement to annual leave for shift workers;
 - preferential treatment of Aboriginal or Torres Strait Islander persons in Local Government employment processes;
 - up to 5 days of Cultural and Ceremonial Leave for Aboriginal or Torres Strait Islander persons in the LGO Award; and
 - inclusion of Flexible Working Arrangements.
- A consent position was reached in relation to the 25% casual loading and flexible working arrangements. The matter was heard over 6 days concluding on 29 November 2024 before Commissioner Walkington and the decision has been reserved.
- State Wage Case:
 - Annually the WAIRC in Court Session issues a decision setting the WA minimum wage.

- The WAIRC will likely call for submission in April and the lodgement deadline for submissions will likely be in May 2026. WALGA intends to submit a written submission on behalf of the Local Government sector.

WALGA's Salary and Workforce Survey closed on 21 November 2025. 82 WA Local Governments completed the survey. The results of the survey are expected to be released in February 2026. Subscribers of the ER Service who completed the survey will have full access to the results of the survey as part of their subscription.

3. GOVERNANCE AND PROCUREMENT

WALGA continues to support Local Governments through the ongoing *Local Government Act* reform process. During November and December, WALGA attended meetings of the Local Government Reform Regulations Working Group and the Integrated Planning and Reporting Working Group, both convened by the Department of Local Government, Industry Regulation and Safety for the purpose of facilitating consultation on regulatory reform proposals.

The first Governance Newsletter of 2026 has been circulated to subscribers, highlighting key reforms requiring action by Local Governments.

During November and December, Governance and Procurement team members facilitated WALGA training sessions and custom workshops both at WALGA and onsite for regional Local Governments.

4. TRAINING

The WALGA Training team continues to ensure all training offerings remain current, relevant, and engaging for the sector.

Training Content Review

Over the past 12 months, the Training team have completed an extensive update of all Council Member Essentials (CME) courses for both in-person delivery and eLearning. Four of the five eLearning modules have been rebuilt using new software, with the review focusing on refreshed content and a modernised learning experience incorporating animation, video, learner reflections and interactive quizzes to support high learner engagement.

A full refresh of the Meeting Procedures module is scheduled for 2026 to capture all legislative changes and deliver an updated, comprehensive program.

The team has also redeveloped and modernised Introduction to Local Government, now offering an interactive induction program to support the sector with a cost-effective onboarding tool for new officers.

New 2026 Projects to build capacity in the sector

Two new training initiatives aim to build sector capability incorporating best practice principles and practical application in specialised fields. These courses will be available in 2026.

Environment and Waste

- 1-day Introduction to Waste for Local Governments (on-site delivery).

- 3-day Local Government Waste Management – Advanced.
- 1-day Introduction to Environment.

Design Review Training

In collaboration with the Department of Planning, Lands and Heritage, this project offers online design review training to support Local Government Planning Officers, Panel Members and Chairs. The modules assist participants to understand and apply design review processes and State Planning Policy 7.0. Five eLearning modules have been developed by the Government Architect Western Australia (GAWA) and WALGA Training has been engaged to host these eLearning modules for easy access to the sector.

Council Member Essentials and Professional Development

The team is currently inputting and verifying recent Elected Member election data into WALGA's database. Of the 578 Elected Members from the 2025 elections, there are 231 who have been elected for the first time. A trend of lower enrolments compared to previous election years has been identified, which is likely influenced by CME exemptions within the five-year period and an overall reduction in Elected Member positions across the State.

As part of the training marketing strategy, Elected Members will be reminded of their legislative obligations and professional development opportunities such as standalone workshops, and the nationally recognised qualification, the Diploma of Local Government – Elected Member, will be promoted to Elected Members who have completed CME and are seeking additional development opportunities.

On-Site Training

Between mid-December and mid-January, WALGA Training received 61 on-site requests for quotation and have confirmed 16 on-site bookings for February 2026 – the highest level of on-site training activity to date and a significant increase from previous years.

Certificate III in Local Government

Following a slower October 2025 intake, there is now a strong increase in enrolments for February 2026, with:

- 8 Trainees enrolled;
- 1 Fee-for-Service enrolment; and
- Additional enquiries continuing to come through.

12.1.4 REPORT ON KEY ACTIVITIES, POLICY PORTFOLIO

The following outlines the activities of the Policy Portfolio since the December 2025 State Council meeting.

1. ECONOMICS

Economic Briefing

In December WALGA released the quarterly Economic Briefing and Local Government Cost Index (LGCI). Previously named for the month of release, this edition is called the Q4 2025 Economic Briefing, using a new naming convention to help clarify which period it refers to. The Briefing provides Local Governments with a snapshot of the current economic climate and economic conditions impacting the sector, as well as unique data and insights tailored for Local Governments in WA.

Western Australia's economy has continued to grow faster than the national average, fuelled by the private sector as public demand eases. While WA's inflation remains above the national level, the Australian economy has grown at its fastest pace in two years, causing inflation to re-emerge as an issue. The Reserve Bank of Australia has maintained interest rates at 3.6%, cautious about the upside risks to inflation.

The labour market remains tight as wages continue to grow, especially in the public sector. These increases, along with rising construction costs, have contributed to a 4.5% annual rise in Local Government expenses over the last 12 months.

Tourism

In November 2025, WALGA hosted a well-attended webinar with Tourism WA (TWA) on the role of local government in tourism. TWA's Director Insights and Strategy spoke to data available and how to determine visitor market segmentation, and TWA's Director Partnerships and Industries provided an overview of the State Government's tourism focus, strategy and avenues of support for Local Government. A new [tourism web page](#) has been included on the WALGA website to provide further resources for the sector.

2. ENVIRONMENT AND WASTE

Regional Waste Management Funding

Following strong WALGA advocacy, on 19 January 2026 the State Government [released](#) \$6 million for regional Local Governments to assist with infrastructure, transport and recycling of plastic, tyres and paper and cardboard. Funding is being provided by the Australian Government, through the Recycling Modernisation Fund focusing on increasing options for materials subject to the [Waste Export Bans](#) – which provides some constraints on how the funding can be used. Grants of between \$50,000 to \$1 million are available.

The funding aligns with WALGA's Budget Submission which seeks \$10 million for regional waste infrastructure, planning and capacity building. WALGA will continue to advocate for additional funds.

Cat Containment

WALGA, and other key stakeholders, received a confidential briefing on the proposed amendments to the *Cat Act 2011* which will allow Local Governments to include cat containment in Local Laws. The Amendments are anticipated in the first quarter of 2026.

WALGA is a member of the Department of Local Government, Industry Regulation and Safety Cat Containment Local Law Working Group.

3. PLANNING AND BUILDING

Urban Greening Strategy

The State Government released the long-awaited [Urban Greening Strategy for Whadjuk \(Perth\) and Bindjareb \(Peel\) Let's Grow: Leafy & Liveable Communities](#) on 16 January 2025.

The long-awaited Strategy outlines how the State Government plans to enhance tree canopy and create more green spaces within the Perth and Peel regions across three action areas – Growing More, Growing Together and Growing Stronger. It sets a canopy cover target 30% for Perth and Peel by 2040, consistent with WALGA's advocacy position. The Urban Greening Strategy also includes an Urban Greening Grant Program for community groups and schools and affirms the State Government's commitment to supporting Local Governments with their public realm planting programs. The Strategy will be supported by the *Let's Grow Action Plan*, which is expected to be released in February.

WALGA has welcomed the release of the Strategy, which has been a key advocacy ask as part of the sectors' drive to increase tree canopy cover in urban areas across the State. Unfortunately the strategy does not extend to urban areas outside of Perth and Peel and does not make any commitments towards reducing the loss of trees on private land, which is critical to meeting the 30% target. Local Governments are leading the way in protecting trees on private land, with nine Local Governments so far adopting WALGA's Model Local Planning Policy that provides regulatory protection for trees of significant size.

WALGA's 2026-27 State Budget Submission is calling on the State Government to invest \$40 million in Local Governments' urban greening programs over the next 10 years to increase access to green spaces and create cooler, more liveable neighbourhoods in urban areas statewide.

Tree Retention Model Local Planning Policy Update

WALGA developed the Model Local Planning Policy (LPP) for Tree Retention in 2024 to regulate trees on private land. Nine Local Governments have adopted the model LPP, providing WALGA with valuable data and insights to inform improvements. The Town of Bassendean has also successfully prosecuted two cases involving the unauthorised removal of regulated trees. A revised version of the model LPP has now been released, incorporating minor amendments to reflect best practice and respond to implementation challenges. A key change is revising the definition of 'maintenance pruning' to be less prescriptive, reducing the need for Development Assessments for pruning activities. Other refinements include restructuring the document to align with current State planning guidelines and removing redundant provisions, such as lists of specific development and subdivision conditions. The [updated model LPP](#) is available to Local Governments to adopt following the procedures set out in the *Planning and Development (Local Planning Scheme) Regulations 2015*, which includes community consultation and consideration by Council.

CoastWA Funding Extension

The State Government announced a three-year extension to the CoastWA Program as part of the mid-year budget review. While the extension of CoastWA is welcome, the funding of \$18.1 million over 3 years is \$2 million less than that provided over the previous three years of the Program. WALGA has advocated for an annual funding of at least \$16 million per annum to cover future adaptation needs for both erosion and inundation, consider rising construction costs, newly identified hotspots, and increasing risks.

Draft Renewable Energy Planning Code – Information Sessions

The Western Australian Planning Commission is introducing a draft Renewable Energy Planning Code and Guidelines to provide a clear and consistent framework for assessing energy infrastructure that supports the generation, storage and transmission of renewable energy across Western Australia. The draft Code proposes consistent development standards and application requirements for renewable energy projects, supported by Guidelines that explain how applicants and decision-makers can meet these requirements.

WALGA hosted two online information sessions on the draft Code alongside the Department of Planning, Lands and Heritage. The first, on 5 February for Local Government officers focussed on how the Code would operate in the current planning framework and the second session on 9 February was for Elected Members to understand the implications of the Code. Comments and questions raised through these sessions will inform WALGA's submission.

Submissions on the Code are due by Friday, 10 April 2026. WALGA is preparing a submission on behalf of the sector for State Council consideration and has requested Local Government feedback by 27 February. Local Governments are also encouraged to make their own submissions. An item on the Code has also been prepared for inclusion in all Country Zone Agendas for the February meetings.

4. EMERGENCY MANAGEMENT

Local Emergency Management Arrangements (LEMA) Improvement Project

WALGA's LEMA pilot project, launched in February 2025, is progressing with five Local Governments: the Shires of Manjimup, Shark Bay, Chittering, Gingin, and the City of Kwinana. The pilot is testing and refining LEMA templates and resources while gathering input to inform future guidance and tools.

DFES, with support from WALGA, has launched an online Statement of Policy, the [Knowledge Hub](#), and continues to develop a LEMA Development Framework. This collaboration has included trialling a new methodology for local emergency risk profiling with each of the pilot Local Governments and preparing summary reports for each, along with an evaluation report on the trial risk workshops.

WALGA and DFES will present the refined templates, key observations, lessons learnt, and proposals for Phase 2 of the project to the State Emergency Management Committee (SEMC) in March 2026. WALGA's delivery of the pilot has been extended until mid-April 2026 to allow for completion of additional deliverables, including an overview for Elected Members on the role of Local Government in emergency management.

WALGA 2026 Emergency Management Forum – 26 May

The WALGA Emergency Management forum will be held on Tuesday, 26 May. The Forum will be filled with expert advice from Emergency Management practitioners, share lessons learned, showcase best practice and collaborative tools, and provide a platform for connection and networking with stakeholders across the sector. More details and registration information will be released soon.

Initial Consultation: Community Recovery Guidelines

A review of the *Western Australian Community Evacuation in Emergencies Guideline* is underway via [Engage WA EM](#). The update aims to deliver contemporary, fit-for-purpose State arrangements that support Emergency Management Agencies in planning and conducting community evacuations for all hazards. Local Governments can provide feedback on the initial review and consultation until 20 February 2026. WALGA provided officer level feedback in the initial review and consultation and prepared a formal submission during the 3-month consultation period, which is expected to be initiated in May 2026.

Revised State Recovery Arrangements Approved

The State Recovery Arrangements were approved by the State Emergency Management Committee on 4 December 2025. The amendments maintain Local Governments statutory responsibility for recovery under the *Emergency Management Act 2005* but provide clearer guidance on how State agencies collaborate to support community recovery. Key changes include:

- State Strategic Recovery Priorities introduced to guide governance, planning, and delivery of recovery in WA.
- Model for Recovery Coordination established, outlining a four-tiered framework (R1 – R4) for recovery coordination arrangements between State and Local Governments.
- Clarified roles and responsibilities for the State Government, including DFES, Hazard Management Agencies and other State Agencies.
- Defined State-level recovery positions, including a new event-specific State Recovery Coordinator Role.
- Clarified arrangements and procedures for transition from response to recovery, community engagement, public information and members.

5. COMMUNITY

WA Multicultural Act Discussion Paper

A [Discussion Paper](#) on a proposed WA Multicultural Act was released by the Office of Multicultural Interests (OMI) on 24 November 2025.

The purpose of the proposed Act would be to formally commit the State to:

- promote inclusion and equity for everyone, regardless of their cultural or linguistic background; and
- ensure that government decisions, services and policies reflect multicultural values like respect, equity, participation and belonging.
-

On 15 January, WALGA hosted a webinar with OMI and 34 attendees from 26 Local Governments (13 metropolitan and 13 regional). The webinar provided an opportunity for OMI to engage directly with Local Government representatives and for the sector to provide feedback on the Discussion Paper. Local Governments represented at the webinar were invited to provide feedback on WALGA's draft submission.

WALGA's submission will be provided to the People and Place Policy Team and State Council for consideration via Flying Minute in time to meet the submission deadline of 28 February 2026.

2026 Aboriginal Engagement Forum – 18 March

WALGA's [2026 Aboriginal Engagement Forum](#) (Forum), will be held on Wednesday, 18 March at the State Reception Centre, Kaarta Gar-Up (Kings Park). Since its inception in 2017, the Forum has provided an opportunity for the Local Government sector to come together and explore leading practice in Aboriginal engagement and reconciliation.

The theme of the Forum is *Kaartidjin kwop koorliny / Empowerment in Action*, with the program focused on opportunities for the Local Government sector to build sustainable employment, business and leadership pathways for Aboriginal and Torres Strait Islander people. The theme aims to build momentum created by WALGA initiatives such as the Preferred Supplier Program's Aboriginal Business Tender and [Kolbang Yanginy](#), the new Local Government Reconciliation Resource. The program was also informed by the Reference Group and outcomes of the 2025 Aboriginal Elected Member Roundtable.

WALGA State Councillors are encouraged to attend the Forum and have been offered a [complimentary ticket](#). A full report on the outcomes of the Roundtable and Forum will be provided at the May State Council Meeting.

2026 Aboriginal Elected Member Roundtable

WALGA's second Aboriginal Elected Member Roundtable will take place on 17 March 2026, the day prior to the Aboriginal Engagement Forum. Now an annual event, the Roundtable enables Aboriginal Elected Members from across the State to connect, meet WALGA's Senior Leadership team and share their experiences and aspirations as Councillors.

With several Aboriginal leaders newly elected and re-elected to Councils in the 2025 Local Government elections, the Roundtable provides an exciting opportunity for ongoing network development, information sharing and partnership.

Rural and Remote Healthcare Advocacy

The need for funding and system reform has been included in the WALGA [Federal](#) and [State Budget Submissions](#) and submission to the Inquiry into Local Government Funding and Fiscal Sustainability. WALGA is also preparing a submission to the Senate Rural and Regional Affairs and Transport References Committee Inquiry into rural, regional and remote Medicare access and funding which closes on 27 March.

WALGA continues to refine its advocacy ask to focus on long-term solutions to this gap in healthcare service funding. In February 2026 WALGA held discussions with key stakeholders in the regional and health sectors to further develop viable options for innovative models of service and funding solutions and areas for joint advocacy.

Working With Children (Screening) Amendment Bill 2025

On 4 December 2025 the State Government introduced the [Working With Children \(Screening\) Amendment Bill 2025](#) (Amendment Bill). The Amendment Bill revises the existing *Working with Children (Screening) Act 2004* to respond to the agreement from the Standing Council of Attorneys-General that States and Territories will implement mutual recognition of negative Working with Children Check (WWCC) notices across jurisdictions.

WALGA does not perceive any direct impacts on Local Government from the Amendment Bill. WALGA provided a [submission to the Phase 2 Reforms of West Australia's Working With Children Check \(WWCC\) Law](#) consultation in October 2025. The submission supported national consistency and portability of WWCC decisions across Australia in addition to other recommendations to support child safeguarding within the sector. WALGA will continue to advocate for increased protections for children and young people including a strengthened WWCC system.

Preventative Health Strategy

On 20 January 2026, the WA Government announced the [development of a Preventative Health Strategy](#). WALGA Executive Manager Policy attended one of the six roundtables with other key stakeholders to inform the development of the Strategy, highlighting key linkages to Local Public Health Plans and WALGA's advocacy asks, including regional and remote health, active transport, road safety, urban planning and climate resilience.

2025 MACWA Awards

On 10 December 2025, in partnership with the Department of Communities, the Department of Local Government, Industry Regulation and Safety and Regional Capital Alliance, WALGA hosted the Most Access Communities WA (MACWA) Awards. These awards acknowledged Local Governments for their efforts in creating accessible and inclusive communities across major and minor projects, public open spaces, employment services and events. Main Roads WA Speed Zoning Policy

That the Central Country Zone supports the Shire of Kulin and resolves to request WALGA to formally approach Main Roads Western Australia seeking a review of the policy-based removal of speed transition buffers across rural and regional Western Australia.

CENTRAL COUNTRY ZONE (Infrastructure Portfolio)

Western Power Pole Top Fires and Network Response

That the Central Country Zone:

1. Recognises the recent spate of pole top fires during the ex-Tropical Cyclone Mitchell weather event as a serious regional and State-wide rural safety concern.
2. Notes that while this matter has been raised by the Central Country Zone, the issues identified are not confined to Zone Local Governments and are likely to affect rural and regional communities across Western Australia.
3. Requests WALGA to assume a State-wide advocacy role on behalf of rural and regional local governments in relation to:
 - a. Pole top mitigation effectiveness in high-risk agricultural environments;
 - b. Network performance;
 - c. Timely isolation of downed or compromised power lines during emergency incidents;
 - d. Protection of volunteer bush fire brigade members operating near live electrical infrastructure; and
 - e. Improved transparency, reporting and communication protocols between Western Power and local governments.
4. Requests WALGA to formally engage with Western Power and the Minister for Energy seeking systemic review, strengthened operational response protocols and enhanced safety protections for volunteer emergency responders across rural and regional Western Australia.
5. Requests that WALGA report back to Member Local Governments on advocacy actions undertaken and outcomes achieved.

CENTRAL METROPOLITAN ZONE (Infrastructure Portfolio)

Standardisation of Road Management Agreements between Local Governments

That the Central Metropolitan Zone requests WALGA to investigate and develop a standardised Road Management Agreement framework, including template agreements and/or standard clauses, for use by Local Governments across Western Australia, in consultation with member Local Governments and relevant road authorities.

EAST METROPOLITAN ZONE (Policy Portfolio)

WALGA Submission to APVMA Advocating for Withdrawal of Second Generation Anticoagulant Rodenticides (SGARS) from Public Sale

That the East Metropolitan Zone requests WALGA submits feedback to APVMA by the 16th of March outlining the following position:

1. Support for the APVMA's proposed suspension of products containing second-generation anticoagulant rodenticides (SGARs), so that stricter controls can be implemented.
2. That the introduction of stricter controls includes the permanent withdrawal of all SGAR products from public sale, and
3. Restrict the use of SGARs to licensed, trained professionals under strict regulatory control.

GREAT EASTERN COUNTRY ZONE (Member Services Portfolio)

Miscellaneous Licence

That the Great Eastern Country Zone supports WALGA's ongoing advocacy in relation to the rateability of land subject to a miscellaneous licence, including to address any uncertainty related to definitions or proposed legislative amendments.

GREAT SOUTHERN COUNTRY ZONE (Policy Portfolio)

Emergency Management Act Consolidation

That the Great Southern Country Zone requests WALGA, as a matter of urgency request that:

1. The State Government reprioritise and expedite the consolidation of the State's emergency management legislation to address the escalating operational and risk issues arising from the current outdated framework;
2. The consolidated acts establish a clear framework to enable the transfer of Bush Fire Brigades to the State Government if a Local Government decides to do so; and
3. Local Governments at the WALGA Zone level be consulted prior to release of the exposure draft bill.

NORTH METROPOLITAN ZONE (Member Services Portfolio)

Elected Member Protections

That the North Metropolitan Zone:

1. acknowledges the increasing vulnerability of Local Government Elected Members to online bullying, harassment, intimidation, and reputational harm, and the associated psychosocial safety risks under the *Work Health and Safety Act 2020*, particularly where harmful conduct occurs through social media and digital platforms;
2. recognises that unlike State and Federal Parliamentarians, Local Government Elected Members do not benefit from absolute parliamentary privilege and only hold limited qualified privilege in the chamber when debating agenda matters. This leaves Elected Members vulnerable to significant personal legal and reputational risk when responding to misinformation, harassment or defamatory claims made outside formal Council proceedings;
3. requests that WALGA advocate for the consideration of legislative reform to introduce protections of Local Government Elected Members in the course of their official duties, including during Council and Committee meetings;
4. requests the Department of Local Government, Industry Regulation and Safety (LGIRS) to provide strengthened legal and procedural guidance for Elected Members responding to targeted misinformation, digital disinformation, or online harassment arising from the performance of their role, and further considers reviewing the Legal

Representation Guidelines to clarify or broaden circumstances where representation may be available in such matters;

5. requests that WALGA examine options which address the motion;
6. requests the Minister for Local Government and LGIRS to commission a review into the use and/or influence of social media pages positioned as community or resident groups, and potential proxy pages, during the 2025 Western Australian Local Government Elections, to identify any breaches of existing codes or misuse of position, and to inform the development of stronger legislative and regulatory frameworks for future elections.

PEEL COUNTRY ZONE (Policy Portfolio)

DFES Funding for Rural Firefighting Water Tanks

That the Peel Country Zone requests WALGA to lobby for the State to establish a risk-based funding program to support the installation and renewal of static firefighting water infrastructure in rural and regional areas. This investment is essential to protect communities, support volunteers and ensure that bushfire risk management responsibilities are appropriately matched with funding.

PEEL COUNTRY ZONE (Infrastructure Portfolio)

Water Corporation's Swan Coast Plains Bridges in Crisis

That the Peel Country Zone request WALGA to lobby for the State to:

1. Urgently assess the state of Water Corporation bridges on the Swan Coastal Plains and implementation of a rapid replacement program.
2. Investigate solutions to keep load limits to a minimum and consider other timely and economical solutions to spanning the drains.
3. Ensure replacement to current fit for purpose standards, and not like for like.
4. Recognise rural bridges in the Water Corporation's annual report and replacement program reporting.
5. Provide State Government funding support to address this hidden economic handbrake and dangerous state of Water Corporation bridge assets.
6. Include bridge standards and requirements in future Water Corporation Services Licence.
7. Refer the matter to the Office of the Auditor General for a performance audit.

SOUTH WEST COUNTRY ZONE (Policy Portfolio)

South West DAMA Update
