Quarterly Economic Briefing now available

WALGA's June 2025 Quarterly Economic Briefing is now available for Members. Containing unique data and insights tailored for Local Governments in WA, this briefing provides an overview of the current economic climate and economic conditions impacting the sector.

WALGA's Renewable Energy Ministerial Forum and release of State Guidelines

As part of WALGA's continued advocacy regarding the requirement for guidelines on Renewable Energy implementation, a Renewable Energy Ministerial Forum was held in June.

State Government Ministers Hon Amber-Jade Sanderson MLA and Hon John Carey MLA addressed Local Governments on their plans for the renewable energy transition and the State Government's priorities. As Minister for Energy and Decarbonisation, Minister Sanderson also engaged in a roundtable discussion with Local Governments, alongside a workshop session conducted by Powering WA that focused on community benefits.

WALGA released its Renewable Energy Community Benefits and Engagement Guide in July to assist Local Governments to navigate renewable energy projects. For more information, go to walga.asn.au

From the Minister

Local Government elections are rapidly approaching and as with all levels of Government, it is so important that our local Councils reflect the diverse communities they represent. That is why I have been encouraging people with a range of backgrounds and life experiences to run for their local Council on 18 October.

Diversity on our Councils ensures that our Local Governments truly represent the interests of their communities. Sharing a variety of ideas and experiences around the decision-making table makes our communities stronger and delivers better outcomes for all.

Local Governments are changing, and have shown a strong commitment to driving inclusion, but I would like to see this accelerated. I hope we can all be part of that change and I look forward to seeing a range of new — and continuing — candidates step up for their community this year.

The dedication of those involved in Local Government was on full display at this year's Local Government Awards, which I had the honour of attending in July. I was really inspired to see the commitment shown by those in the sector to serving and shaping their local communities — often over decades. I hope to see this level of passion continue as our new Council candidates discover the positive and lasting impacts they can make.

The Cook Labor Government is also committed to encouraging more people to vote in Local Government elections and get engaged in this important level of democracy.

That's why I am looking at moving to a four-year full Council election cycle, which will not only combat voter fatigue, but will also relieve the financial burden on Councils of having to conduct elections every two years. Having all members elected at the one election also means that their agenda is clear; they train together and plan together to ensure they're on the same page and can avoid the disruption that comes with competing mandates at different elections.

One of the emerging areas many Local Governments are currently considering is their approach towards renewable energy projects. To assist with this, the Cook Labor Government has released our draft guideline on community benefits

for renewable energy projects to ensure that all Western Australians benefit from the energy transition.

Some regional communities are located where strong renewable resources can play a key role in the energy transition, meaning these local communities will be well placed to benefit from the creation of local jobs, supply chain opportunities and broader benefits.

I'd also like to take this opportunity to provide an update on the Government's Local Government reforms.

Feedback received from consultation regarding proposed requirements for CEO KPIs and online registers is currently being considered — thank you to everyone who contributed. The focus will soon turn to reforms related to standardised meeting procedures, communications agreements and council plans as we continue to implement the remainder of the tranche one reforms.

Consultation has just closed on the draft regulations to establish communication agreements between Councils and their administrations. I recognise many Local Governments already have these in place, however, we want to ensure we get the regulations right and reflect the standards we want to implement across the sector.

Further regulations are being prioritised to implement key reforms from the tranche two amendments, including the establishment of the Local Government Inspector; implementing audit, risk and improvement committees; rates and revenue policies and reforming regional subsidiaries.

Development of regulations to implement these important reforms will occur in consultation with the WA Local Government Association and Local Government Professionals WA.

I look forward to continuing to work productively with these organisations to achieve further progress in the sector and even better outcomes for our communities.

From the **Shadow Minister**

If the last few months have taught us anything, it's that Local Government plays a vital role in our communities and deserves stronger support to truly thrive and reach its full potential. You know it as well as I do — Local Governments are closest to their communities, listening, responding, and delivering where it matters most.

Local Governments have been in the spotlight in recent months, with several issues continuing to draw public attention. As Shadow Minister, one of my key responsibilities is to listen and advocate to ensure Local Government is empowered and supported. That means being on the ground, hearing directly from councils, and seeking answers from those responsible.

From Albany to Geraldton, to the Goldfields and to the Murchison, I've been engaging with Local Governments to understand their concerns and explore the opportunities ahead. I remain in regular contact with WALGA, Councillors, and sector representatives to ensure I'm well-informed and actively representing the needs of the sector.

Since the last edition, the State Government has released a Community Benefits Guideline for renewable energy projects. However, at this stage, it remains just that — a guideline. The feedback I've received from Local Governments indicates a strong desire for a more robust framework, including the possibility of mandating — at a minimum — formal consultation requirements.

Whether it's renewable energy projects, waste management, planning, or even issues like dogs and cats, it's essential that State Governments work with Local Governments, not around them. Local Government is on the front lines, closest to communities, and must be supported to ensure no one is left behind. Your local knowledge and insight are invaluable, and your voices must be heard accordingly.

Amalgamations and boundary adjustments have come into sharp focus. My public position is clear: that any top-down approach which forces amalgamations that strips away local decision-making, or reduces local representation, will be met with strong resistance. I've requested briefings with the Minister for Local Government to better understand the mechanisms and processes being followed, to ensure community voices will genuinely be heard.

The State Budget was handed down in June. Pleasingly, many of the priorities outlined in WALGA's *The West at its Best* submission received some funding. However, key areas still fell shortincluding roads, sport and recreation and culture and the arts.

Reform within the sector has been a long process, and I know many are now looking ahead to the implementation phase — particularly the establishment of the Office of the Local Government Inspector. The Legislative Assembly Estimates in July provided an opportunity to explore the detail further, with specific questions raised about the Inspector's Office. The indication given was that it will be up and running by the end of this financial year.

It is hoped that this Office will be of real benefit to the sector — offering support, guidance, and assistance, particularly during times of uncertainty, transition, or when additional oversight is required.

By now, most Local Governments have adopted their budgets and entered rating season. I regularly hear that the sector is being asked to do more with less, which impacts the ability to deliver on community expectations and priorities. Advocacy for greater financial assistance has long been on the agenda, including the sector's call for a fair percentage share of the GST revenue base. I have urged the State Government to listen to the sector's request for a long-term, formula-based funding model that would provide much-needed sustainability. I will continue to raise this issue to ensure it remains a priority.

Despite the challenges, there are many promising opportunities within the Local Government sector. I regularly witness the dedication and hard work of Local Governments across WA, who are committed to delivering essential services and improving their communities. Their efforts in areas such as infrastructure, community engagement, and environmental management deserve recognition. I commend those Councils that are leading by example and continuously striving to meet the needs and expectations of their residents. With the right support and resources, the sector can build on these strengths and achieve even greater outcomes across the state.

I encourage you to get in touch with my office if you have any questions or concerns. I remain committed to listening and advocating to ensure the voice of Local Government is heard.

From the **WALGA President**

In June, I joined more than 110 WA delegates from over 40 WA Local Governments in Canberra to represent and support Members and their communities at the Australian Local Government Association (ALGA) National General Assembly.

Almost 190 motions were debated across a range of policy areas, including financial sustainability, roads, disaster resilience, health, housing and climate change.

The event provided opportunities for Local Governments across Australia to advocate on behalf of their communities on a national platform.

Congratulations to the City of Stirling, City of Gosnells, City of Wanneroo, Town of Victoria Park and the Shire of Murray, who were all awarded National Awards for Local Government for their work with women in Local Government, addressing violence against women and children, disaster readiness, cohesive communities, productivity through infrastructure, arts and culture, regional growth, and environmental sustainability.

In June, WALGA was disappointed with the National Management Group's decision to abandon eradication plans for the Polyphagous Shot-Hole Borer (PSHB). WALGA's position is clear — a transition to management should not be a transition to Local Governments shouldering the full costs of managing PSHB long term.

WALGA continues to advocate that Local Government, and other key stakeholders, must be actively engaged in the development of long-term management arrangements.

In July, WALGA released a Renewable Energy Community Benefits and Engagement Guide to assist Local Governments to navigate large-scale renewable energy projects. The Guide provides Local Governments with a practical framework to understand their role, engage with developers and their communities, and advocate for lasting economic benefits from these projects. It also empowers Local Governments to ensure they act upon the unique needs of their communities. WALGA has welcomed the Draft Guideline on Community Benefits for Renewable Energy released by the State Government in June, while reaffirming the need for Local Governments to be included in decision making.

In mid-July, we brought the WA Local Government sector together for the annual WALGA Local Government Awards, which recognise and celebrate outstanding achievements and lasting contributions made by Elected Members, Local Governments, and Officers to their communities.

In August, we were thrilled to welcome the Hon Jessica Stojkovski MLA, Minister for Child Protection; Prevention of Family and Domestic Violence; Minister Assisting the Minister for Transport; Peel to WALGA's Transport and Roads Forum. The State Government announced the first tranche of the Regional Road Safety Program with an allocation over \$39 million to 27 Local Government projects, as part of the State Government's \$125 million commitment, which WALGA advocated for as part of our 2025 State Election Priorities.

With the 2025 Local Government Elections being held in October, we would like to see more community members interested in running for Council.

WALGA, in partnership with the State Government, is running a targeted campaign in the lead-up to the October elections that aims to increase diversity of Council nominations and voter participation.





More than 140 Local Government People and Culture, Human Resources and Industrial Relations professionals, leaders and CEOs attended WALGA's People and Culture Seminar for 2025.

The year's theme, "Leading People: Compassion, Compliance and Collaboration" delivered a great mix of topics and provided attendees with key takeaways and new ways of thinking for working better across our Local Governments now and into the future.

The People and Culture Seminar is a landmark event in the Local Government calendar, and one that WALGA has been proud to run for more than 15 years.

Transport and Roads Forum

In August, WALGA in partnership with Mains Roads WA, hosted the 2025 Transport and Roads Forum at Fraser's State Reception Centre in Kings Park, hosting more than 200 delegates.

The Forum saw an opening address by the Hon Jessica Stojkovski MLA, Minister for Child Protection; Prevention of Family and Domestic Violence; Minister Assisting the Minister for Transport; Peel. As part of her opening address, Minister Stojkovski announced the first tranche of the Regional Road Safety Program with more than \$39 million allocation to 27 Local Government projects, as part of the State Government's \$125m commitment to the RRSP.

WALGA President Karen Chappel AM JP outlined the challenges faced by WA Local Governments, who have responsibility for more than 87 per cent of the road network in the State and the critical role Local Government plays in our road networks.

The day brought together experts and leaders across all facets of Local Government, Transport and Roads.



Productivity meets work-life balance in Vincent's innovative workplace scheme

After a successful trial and independent evaluation from Edith Cowan University, the City of Vincent's innovative workplace Productivity Scheme will continue.

It started as a trial in July 2024.

During the trial, staff who opted in were challenged to demonstrate efficiencies and innovation.

Those who were able to achieve this were offered the opportunity of taking up to 10 per cent of their contracted hours as productivity leave.

To ensure the trial was evidence-based, the City of Vincent commissioned an independent evaluation by researchers from Edith Cowan University (ECU). The study involved 50 interviews and a staff survey.

The results were encouraging:

- Staff turnover dropped by 15% to 14.79%
- Employees reported improved morale, job satisfaction, work-life balance and wellbeing
- Many staff cited the trial as a key reason they intended to stay with the organisation — even over better-paid roles elsewhere
- Teams became more focused on reducing inefficiencies, improving systems and collaborating to meet shared goals.

An evaluation report found 96% of surveyed participants supported the continuation of the trial and 77% of employees rated the effectiveness four or five stars.

The ECU researchers recommended that the scheme should continue, and it is now ongoing while continuously being reviewed.

"We are not aware of any public sector agency in Australia that has taken this innovative approach to simultaneously improve productivity, staff retention, employee health and wellbeing. Our team have worked hard and worked smart to make this a permanent feature of a career at the City of Vincent," said City of Vincent CEO David MacLennan.

"Since COVID-19, an ongoing challenge for most organisations remains around retention and attraction of skilled and experienced staff.

"In a competitive job market, the scheme helps us attract and retain the staff we need to deliver vital community services."

Mr MacLennan said staff turnover rate has dropped by 15%, with increased efficiencies across teams and happier staff.

"Retaining staff reduces turnover, training costs and service disruption, which in turn, results in a long-term saving for the organisation and ultimately for ratepayers."

Professor Ben Farr-Wharton from Edith Cowan University said the participants reported increased perceptions of wellbeing, work-life balance, job satisfaction, team cohesion and intention to stay employed at the City of Vincent.

"As public sector researchers, we were genuinely impressed by the innovative mindset demonstrated by City of Vincent staff and leadership," he said.

"Government organisations are often under pressure to 'do more with less' — a concept that, mathematically speaking, doesn't add up.

"Research shows this approach typically leads to employees working harder in the short term, but over time, it results in burnout, high turnover, and disengagement.

"Our research supports a shift towards 'doing better with less' — an approach where public sector leaders work collaboratively with staff to identify efficiencies that preserve wellbeing and service quality.

"The City of Vincent exemplifies this more mature and sustainable approach — prioritising both performance and people."

Mr MacLennan assured that Vincent was still open for business, and through effective rostering, service levels and turnaround times were not impacted.

All staff are still paid for their contracted hours and are expected to be on-call during their productivity time off, if required.

"We continue to answer phone calls, and our fantastic Customer Relations team are still available for in-person support," he said.

"Development Applications are still being assessed in a timely manner. Rangers, rubbish collectors and the parks team continue to do their front-line jobs effectively.

"We want to ensure the team at Vincent are happy to be at work so they can continue to deliver the essential services and projects our community expect."

Subscribers to the service have access to support on a wide range of tax issues, including Goods and Services Tax (GST), Fringe Benefits Tax (FBT), Fuel Tax Credits, and PAYG withholding.

This technical support ensures Local Governments are aware of changes to tax law and are able to resolve tax issues efficiently and effectively.

Subscribers also have access to the full range of fee for service offerings from Moore Australia outside the scope of the service.

The new pride of City of Bunbury

Hands Memorial Oval a game-changer for community

Over 10,000 local, national, and international patrons experienced football at its finest on Bunbury's Hands Memorial Oval on Saturday 5 July with a tightly contested match between the CommBank Matildas and Panama Women's National Team.

The clash occurred only weeks after the historic AFL game between North Melbourne and West Coast Eagles – drawing a record crowd of 12,715 at the newly redeveloped precinct.

The redevelopment, which was completed in 2024, elevated the facility's status as the premier Australian Football League destination in regional Western Australia, with the centrepiece of the project a new two-storey stadium with a seating capacity of 750 spectators.

With a focus on sustainability, versatility and enhanced spectator experience, the redevelopment included a new entrance, ticket boxes, parking, road upgrades, change rooms, function space and media facilities. The facility now meets AFL Category 4 standards while ensuring inclusivity for people of all abilities.

Facilitated by the City of Bunbury, the addition of six temporary grandstands located around the oval enabled spectators to be very much a part of the game day action.

Bunbury Mayor Jaysen Miguel said the redevelopment of Hands Oval has been a game-changer for Bunbury.

"Hosting major events like the AFL and Matildas games so soon after completion shows just how valuable this investment is, not only in terms of community pride and participation, but also in the economic and social benefits it brings to our city," said Mayor Miguel.

"These events bring visitors, boost local business, and create unforgettable experiences for our residents.

For the AFL pre-season and in-season matches, as well as the Matildas fixture, City of Bunbury staff across Infrastructure and Corporate and Community teams pulled out all stops to deliver each event to the highest possible standard.

This included delivery of event logistics, waste services, temporary infrastructure, marketing, and communications. The Events and Place Activations and Marketing teams worked closely with North Melbourne Football Club and Tourism WA to showcase Australia's South West to patrons including the

presence of a WA Culinary Experience marquee featuring local wines and produce.

Officially known as JE Hands Memorial Park, the ground has been the primary venue for Australian football and cricket in the region, and over the years it has hosted soccer and rugby union matches, as well as state cricket.

Serving as the home of the South Bunbury Football Club and Southwest Football League, it has hosted five WAFL matches since 1984.

The project was funded through \$6.8 million from the City, \$8 million from Department of Local Government, Sport and Cultural Industries' WA Recovery Plan funding, \$4.4 million through the Federal Government's Building Better Regions Fund, \$200,000 from the West Australian Football Commission, \$150,000 from South West Football League and \$5.7 million for additional AFL fixtures from the Department of Primary Industries and Regional Development.

Bird Waterer a National Success

From the outside, some might assume the environmental focus of Local Government boils down to little more than planting a few extra trees.

If the Town of Victoria Park's oversubscribed community planting days this winter were any indication, there's plenty of enthusiasm for that kind of mission — but as the small inner-city LG's recent national award win for one of its pet projects has shown, there's much more to its environmental approach.

Now installed at more than 130 locations across Western Australia, many had already heard of the Town's innovative bird waterers when they appeared amongst the nominations for the 2025 National Awards for Local Government, ultimately winning the popularly voted Environmental Sustainability category.

Designed by Town staff in response to community concerns about dwindling fresh water sources for black cockatoos, the bird waterer – commonly referred to as the Cockitrough® – elevates a series of self-filling and cleaning water troughs away from roads and predators and has become a common sight in parks around the metro area and beyond.

Town of Victoria Park Mayor Karen Vernon said the Cockitrough® had captured the imaginations of the community ever since the first prototype was installed at the local Jirdarup Bushland in 2018.

"The Cockitrough® has proved a popular and cost-effective solution for hydrating wildlife, with more than 130 units now purchased and installed across WA by Local Governments, schools, conservation groups and environmentally conscious individuals

"The national award, which is voted by the public, is even more evidence of the popularity of the Cockitrough®, and we as a Town are hugely proud of the impact it continues to have for our local birds and, in some cases, marsupials."

Interestingly, Jirdarup Bushland's importance to the Town's environmental work is not limited to being the first home of the Cockitrough®. Vic Park's annual planting program is also heavily tied to the area, propagating native endemic seed from the site for planting throughout the surrounding suburbs. This in turn has led to the ongoing creation of a 'wildlife corridor' of hyper-native plantings via community planting days, extending food sources and habitat for wildlife from the bushland south past Curtin University.

Meanwhile, whilst originally designed for the state's endangered black cockatoos, the Cockitrough® has been recorded serving up a drink to all manner of birdlife, from honeyeaters, ravens, willy wagtails and magpies, to galahs and, of course, the humble lbis.

The Cockitrough® is available for Local Governments, conservation groups, universities, schools, and businesses looking to improve urban bird habitats.

With the invention showing up all over the State in the City of Belmont, Shire of Murray, Shire of Waroona, City of Canning and Shire of Mundaring, just to name a few, be sure to keep an eye out as these innovative bird waterers make their way to a suburb near you.

Kalgoorlie-Boulder becomes latest Local Government to join WALGA's RoadWise Program

WALGA's RoadWise Program continues to support WA Local Governments to make local roads safer.

The City of Kalgoorlie-Boulder has joined the growing network of Local Governments working to make roads safer, officially becoming a registered WALGA RoadWise Council.

Representatives from WALGA's RoadWise Program presented Mayor Wilson with the City's RoadWise Council plaque, as formal recognition of the City's renewed commitment to road safety for all road users.

Joining the RoadWise network provides the City of Kalgoorlie-Boulder with support to identify priority projects, review local road safety data, update policies and processes, and further focus efforts and investment where they can make the most difference.

City of Kalgoorlie-Boulder Mayor Glenn Wilson acknowledged the community's role in driving this initiative forward, particularly the advocacy of local resident Daniel Campo, whose son Nick tragically died in a car crash last year.

"Daniel's determination is a powerful reminder of why this work matters. Road safety isn't just a statistic – it's deeply personal. Every decision we make about our roads has the potential to prevent another family from experiencing that kind of loss," Mayor Wilson said.

"Here, between Kalgoorlie and Northam, there's only one billboard reminding drivers to stay safe. There's a lot we can do to advocate for better awareness and safer environments on our regional roads, especially given the long distances people travel out here.

"Importantly, being a part of the Program also strengthens our ability to advocate for safer roads and work with other Local Governments and agencies on practical, community-focused initiatives," he said.

WALGA President Karen Chappel AM JP commended the City of Kalgoorlie-Boulder for formalising its commitment to road safety through RoadWise.

"As road managers, Local Governments are a critical stakeholder and key partner in road safety," President Chappel said.

"RoadWise aims to build an informed and committed sector with safe system principles integrated into the way the local road network is managed, ultimately making an effective contribution to the achievement of National and State road safety objectives and targets."

Across Western Australia, 66 Local Governments have committed to the program.



How Local Government can influence capacity charges on energy costs

While Local Government Authorities (LGAs) need financial resilience to provide their communities with critical services and infrastructure, they are not immune to rising costs. Synergy is working proactively to help customers find opportunities to reduce energy costs.

According to Synergy Account Manager Luke Randell, LGAs who can reduce their demand for electricity when the load on the energy system is at its highest could take advantage of the potential for lower capacity charges.

"In current economic conditions taking steps to influence capacity charges could make a substantial difference. Your LGA's capacity charges are influenced by how much electricity is consumed on Peak Demand Days, which are the four days with the highest demand in the SWIS during the hot season." said Mr Randell.

Capacity charges support WA's demand for electricity

As Mr Randell explained, the Australian Energy Market Operator (AEMO) manages the reserve capacity mechanism in the South West Interconnected System (SWIS). As an electricity retailer, Synergy pays AEMO for capacity based on the amount of electricity it requires to meet its customer demand, with this cost being apportioned to customers through either a capacity charge or as part of a bundled price for electricity, depending on the type of electricity supply agreement.

To determine the capacity liability, AEMO uses the median value of consumption during the Peak Demand Intervals, which are three consecutive 30-minute intervals across four days between 1 December and 31 March when system demand is highest.

"Your demand during these intervals affects your capacity charges during the next capacity year, which begins on 1 October and concludes on 30 September the following calendar year," said Mr Randell.

"Since capacity charges are based on the days when demand in the SWIS is highest, reducing electricity use during these times, generally between 5pm and 9pm on the hottest days in summer, could mean the capacity charges that are payable by you the following capacity year could be lower. This also has the benefit of helping to balance supply and demand across the SWIS."

Electricity management can impact capacity charges

Mr Randell noted that businesses may use an electricity management practice known as "peak-shaving" to reduce electricity use during predicted peak times, to potentially reduce their capacity charges for the next year.

"We recommend looking at your LGA's electricity consumption to identify periods of high electricity usage. You could do this by taking advantage of usage interval data and other features in My Account, which can help you to monitor and manage your electricity consumption."

"Some businesses find they can adjust for days that are likely to be Peak Demand Days, for example making changes to air conditioning settings, encouraging staff to work remotely, or powering down energy-hungry equipment for the time when demand on the SWIS is likely to be highest."
