#### **Technical Advice**

- Free technical heritage advice.
- Advice from the Heritage Team prior to lodgement of a development application.

### Who can apply?

All properties on the City's Heritage List.







# Waiver of DA Fees

#### Waiver of DA Fees

- Works which are in the public view and enhance the heritage significance of the property.
- Urgent conservation works required to stabilise a building.
- Examples of such works include but are not limited to restoration to facades, restoration of verandahs etc.

### Who can apply?

All properties on the City's Heritage List.







### Rates Concession

#### **Rates Concession**

- Owners of residential and commercial properties included on the City's Heritage List.
- 50% rate concession on the general rate levied.
- Commercial properties capped at \$2,000 per property.
- This concession must be applied for annually.

All properties on the City's Heritage List.







### Heritage Restoration Rebates

### Heritage Restoration Rebates

- Formerly known as Heritage Grants
- Conservation and maintenance of their property.
- Rebate payments are issued after completion of works.
- Half the value of the works up to \$5,000.
- Eligible properties can apply each year for different works.
- City budgets \$60,000 each year.

### Who can apply?

All properties on the City's Heritage List and properties categorised as 1 or 2A on the City's Local Heritage Survey.

The house above at 39 Coode Street. Mt Lawley (formerly Maylands) was built in approximately 1919 and first occupied by the Halliday family. The photo shows Ruby and four of her children in the newly built house. Robert (1879-1951) and Ruby (1882-1969; nee Parsons) were married in Perth in 1901 and went on to have ten children namely Ethel (1902-1982), Henry "Bob" (1903-1986), Royden (1907-1977), Wynne (1910-1977), Clifton (1912-1988), Florence (1915-1998), Keith (1919-1919), Joan (1921-2008) and Thelma (1925-2021). Robert got his first job with the railways in 1896 as a porter at Perth station on 5 shillings per day, becoming a guard at Midland Junction in 1903 and a platform inspector in 1933 on £234 per annum. He retired in 1944 receiving a testimonial from Harry Shearn (MLA for Maylands) of 42 Third Avenue, Mt Lawley. Mr Shearn wrote in appreciation of Robert's service and his "great courtesy and general zeal" when dealing with the


