There is not a lot to report at present as final project acquittal figures for the year are not know at this point. I have heard from MRWA GSR that the acquittals are pretty good, but we will see.

The GSRRG has been allocated \$8M over two-years to complete specific road works in the Secondary Freight Network and this process is being worked up as to the criteria for those projects.

It is currently thought that up to four key projects for the first years' funding for the key freight routes that will benefit the whole region will be the target for this funding. The GSRRG Chair has been in discussion with MRWA GSR staff to work up a proposal to take to a meeting in the near future to enable the funding to be utilised and acquitted on time.

Some of the funding can be used for planning. At the last GSRRG meeting held in Kojonup, it was resolved to set aside \$500,000 for this planning / roads study. This was reduced by MRWA to \$250,000 and this level of funding should be manageable for this level of study. MRWA staff have been very helpful as we begin this process.

As a key part of this process, MRWA will be requesting road use data in the form of traffic counts and the like from each Local Government in the GSRRG. This will inform the basis for this study. Once the study is complete an advocacy document will be produced that will detail the already known impacts of heavy freight on this network, the known shortfalls that exist currently and the expected future impacts.

#### **Zone Financial Report for May 2023**

Financial statements for the zone have been prepared on an accrual basis and show the financial performance and financial position for the period ended 31 May 2023.

#### **DAMA Project**

Income includes contributions to fund the DAMA project, totalling \$70,000 (ex.GST) which have been invoiced and collected.

As the project is expected to cost less than the contributions, the expense for the project brought to account includes invoices submitted by EY for work done to 31 May 2023. These include the first two instalments totalling \$30,900 and the most recent invoice for an additional expense of \$10,300 for payment in June.

The balance of DAMA funds held by WALGA, which is managing the collection and disbursement of project funds, is currently \$39,100 before the payment of the most recent invoice of \$10,300.

A recommendation on the application of the surplus funds can be determined at the next meeting when the project is expected to be complete and the balance confirmed.

There seems to be an increasing interest for people to move to the Great Southern and the DAMA, if supported by the Department, will ensure continued growth in the region. This puts pressure on the limited housing available and delays in building new homes. There is funding support from both the State and Federal governments for new housing development so I hope some of this assistance will find its way into this region.

As mentioned at the last Great Southern Zone meeting, our Zone will be hosting WALGA State Council on the 12th & 13th September 2023 in Katanning. This is a great opportunity for our members to present on day one to the wider local government sector on our achievements and also constraints. All elected members in the Zone will be able to attend, meet State Councillors and socialise on the Tuesday afternoon.

The DAMA Working Group has been very busy since the last Great Souther Zone meeting and is happy to report the Business Case was submitted to the Department of Home affairs on the 30th May 2023 and the Department confirmed receipt the very next day.

The consultant, EY Global, expects to hear back from the Department around the end of June.

To build up this Business Case took a lot more work than I originally expected and thanks to the support of Working Group members in contacting local businesses, providing regional data, responding to dozens of emails and attending "MS-Teams" meetings. Special acknowledgement to Renee Tan from the GS RDA office in keeping us all in check and performing much more than the Designated Area Representative role requires.

WALGA though Lyn Fogg and Rick Murray have also been a great help in not only the administration but also in the financial controls in the EY engagement.

So far, we have come in under budget however the Department may require amendment or information and if so EY will need to undertake extra work. Subject to acquittal of costs associated with any additional work required, the unspent funding will be retuned to the Zone member Local Government's pro-rata to their contributions.

Now the word has spread our larger local businesses are very keen to peruse options through the DAMA so this has been a great initiative by the Great Southern Zone. The Minister for immigration has indicated he will be implementing immigration reform in the future so we hope this will not conflict with our mission.

### 7.2.2. Regional Housing – Development WA land development funding assistance

The State Government's 2023-24 State Budget includes increased funding to DevelopmentWA's Regional Development Assistance Program, targeted to assist Local Governments to fund projects in regional towns, where there are either limited or no active private developers developing land for release to the local market.

RDAP funding assists Local Governments to develop land projects to stimulate local economic and social activity, including residential, industrial, commercial and tourism uses.

#### **EXECUTIVE SUMMARY**

- Consultation for Stage 3 of the review of the Biosecurity and Agriculture Management Act 2007 (BAM Act) has commenced, with feedback sought on potential biosecurity reform opportunities.
- WALGA has developed a draft Submission for sector feedback by 26 June.
- Zones are asked to consider and provide feedback on the proposals in the discussion paper and WALGA's draft Submission.
- Local Governments are also strongly encouraged to provide feedback directly to the Review Panel via the online portal by 30 June 2023.
- Local Governments are invited to attend a WALGA webinar on the proposed reforms, which will include a presentation from the Chair of the Independent BAM Act Review Panel, Kaylene Gulich, at 10.30am, Wednesday 14 June.

#### **BACKGROUND**

The first 10-year <u>statutory review</u> of the <u>Biosecurity and Agriculture Management Act 2007</u> (BAM Act) is currently underway; this is a key opportunity for Local Government to influence the how post-border biosecurity is managed in Western Australia. The <u>Independent Panel</u> undertaking the review, is using a three-stage engagement process.

**Stage 1** (closed) - Used open submissions and a survey to identify major themes and issues. To inform comment on this stage of the review WALGA prepared a <u>Discussion Paper</u> which includes 11 key biosecurity themes and related recommendations reflecting issues raised by Local Government, and those identified in the <u>Auditor General's 2013 and 2020 Reports</u>.

**Stage 2** (closed) - Stage 1 identified the key themes and stage 2 provided an opportunity to focus on these issues, which included:

- principles to underpin WA's biosecurity, including biosecurity in all contexts and shared responsibility.
- legal foundations of WA's biosecurity, including prioritising pests, weeds and diseases, and enabling industry and community action.
- planning, coordinating and resourcing WA's biosecurity system, including responsibilities and timing.
- community-led pest and weed management, including the Declared Pest Rate and Recognised Biosecurity Groups.

**Stage 3** – (now open) A <u>Discussion Paper</u> sets out nine priority reform areas, and identifies 21 opportunities to clarify, strengthen and support a strengthened biosecurity system in WA. The nine priority reform areas are:

- 1. Clarifying the role of the BAM Act
- 2. Working together to protect WA
- 3. Planning and reporting- vital to a better biosecurity system
- 4. Prioritising pests and diseases
- 5. Emergency powers- a necessary precaution
- 6. Compensation can boost biosecurity efforts

- 7. Enabling industries to act
- 8. Community-led pest management
- 9. Compliance with WA's biosecurity laws.

#### **Policy Implications**

Current WALGA Advocacy Position: 4.5 Post Border Biosecurity

Western Australia's economy, environment and the community are facing increasing challenges posed by already established and new pests, weeds and diseases. Local Government has a significant role in biosecurity management, as land managers and regulators, and therefore has an interest in ensuring that Western Australia's biosecurity system, including control of declared pests, is effective and appropriately resourced. WALGA considers significant changes to the operation of the State's biosecurity system, including the Biosecurity and Agriculture Management Act 2007, are required to ensure these risks can be managed now and into the future.

To be effective the Western Australian biosecurity system must:

- 1. Take a transparent approach to the notion of 'shared responsibility' by ensuing that:
  - a. The respective roles and responsibilities of Commonwealth, State and Local Government, industry, landholders, community groups and individuals are agreed and clearly articulated; and
  - b. There is improved pest management on State Government managed land and a formalised structure for State Government agencies with responsibilities for biosecurity management to work together and coordinate their activities.
- 2. Be underpinned by a strategic framework, developed in collaboration with stakeholders, that:
  - a. Establishes priorities for biosecurity threats in geographically defined regions, sets measurable targets and guides investment in biosecurity activities; and
  - b. Is regularly evaluated and reported on.
- 3. Have a greater focus on environmental biosecurity, through the increased recognition and management of pest species that have significant ecological impacts.
- 4. Be adequately, sustainably and equitably funded:
  - a. The appropriateness and effectiveness of the Declared Pest Rate (DPR) and Recognised Biosecurity Group (RBG) model as key mechanisms for the management of widespread and established declared pests should be reviewed and alternate mechanisms considered;
  - b. Increased and more equitable distribution of funding for every step in the biosecurity continuum and adequate resourcing for all stakeholders, including Local Government; and
  - c. The provision of funding for declared pest management in metropolitan areas.
- 5. Ensure that the criteria and process for listing of declared pests is evidence-based, timely and transparent.
- 6. Have an increased emphasis on compliance through education and enforcement activity, to ensure land managers are aware of their legislative responsibilities and are supported to implement biosecurity actions.
- 7. Facilitate the use of new technologies, strategic monitoring, and the establishment of data management systems to inform biosecurity investment decisions and support adaptive management.
- 8. Improve the community's understanding, awareness and action in relation to biosecurity to assist with threat surveillance and timely response to incursions.

- The unions' current and future claims to amend the <u>Local Government Officers' (Western Australia)</u> Award 2021 (LGO Award) and the <u>Municipal Employees (Western Australia)</u> Award 2021 (ME Award).
- The amendments to the State awards that are required by Local Government employers including to develop an employer log of claims.
- The standard terms and conditions of employment in the Local Government sector.
- The constraints of the Local Government sector. For example, a Local Government's capacity to pay.

The Working Group's purpose is associated with employment arrangements for Local Government employees, therefore membership will be officer only (being an operational matter aligned with the CEO's functions under s.5.41 of the Local Government Act).

WALGA Employee Relations sought expressions of interest from Great Southern Country Zone CEO's, via:

- Expression of Interest letters sent to all CEO's on 9 May;
- ER Alert (email) distributed on 9 June
- Deadline to respond was extended to 14 June

At the close of nominations, only one nomination had been received from Great Southern Country Zone Local Governments, with the City of Albany's nomination of their Acting Manager People and Culture having now been accepted. The confirmed representatives will be notified to all Zone CEO's early next week.

#### STATE COUNCIL Item 7.1 Review of Urban Forest Advocacy Position

#### **Executive Summary**

- It is proposed that the 2017 Advocacy Position 4.6 Urban Forestry be replaced with a new position that reflects Local Governments' urban forest advocacy priorities.
- The new position has been prepared in collaboration with the officers of the Local Government Urban Forest Working Group and has been endorsed by both the People and Place Policy Team and Environment and Waste Policy Team at a special joint meeting on 31 May 2023

#### **Recommendation**

That WALGA endorse a new Advocacy Position 4.6 Urban Forest as follows:

To promote the growth of Western Australia's urban forest the State Government should:

- 1. Identify a lead agency with responsibility for setting the strategic direction and oversight of urban forest initiatives.
- 2. In consultation with Local Government:
  - a. Develop an Urban Forest Strategy, based on the overarching principles of a resilient, connected, expanded and equitable urban forest including:
    - i. an overall tree canopy target for the Perth and Peel regions,
    - ii. robust and contemporary data to inform decision making,
    - iii. funding mechanisms to support growth in urban canopy.
  - b. Develop contemporary legislative and policy mechanisms to enable the protection and growth of urban forest, including:

- i. an effective and efficient regulatory mechanism that allows Local Government to consider the removal or alteration of a significant tree as a form of development.
- ii. prioritisation of trees and vegetation as a key structural element in the design of new neighbourhoods to facilitate climate resilient and liveable communities.
- iii. consideration of public realm design to maximise opportunities for tree retention and new planting consistent with any tree canopy targets.
- 3. Work with Local Government and other stakeholders to increase community awareness and promote behaviour change in relation to urban forest growth and retention to support State and Local Government targets and action.
- 4. Provide recurrent funding for a comprehensive and accessible Urban Greening Grant program to support Local Government investment in public realm planting, focusing on high urban heat areas and enhancing biodiversity outcomes.

#### STATE COUNCIL Item 7.2 State Planning Policy 3.7 Bushfire

#### **Executive Summary**

- State Planning Policy 3.7 Bushfire (SPP3.7) directs how land use and planning proposals should address bushfire risk in Western Australia. It applies to all land designated as bushfire prone, which is approximately 93% of the state.
- The Department of Planning, Lands and Heritage has released a revised version of SPP3.7 and Planning for Bushfire Guidelines for public comment.
- Future changes to the Map of Bush Fire Prone Areas are planned that will create a revised mapping standard for lower risk areas, such as significantly built-up urban areas.
- The revised SPP 3.7 and Guidelines propose a nuanced response compared to the existing policy framework, with the intent of better reflecting the type of planning or development proposal and the level of bushfire risk.
- WALGA's submission generally supports the revised SPP3.7 and Guidelines. The more nuanced policy response better reflects the level of bushfire risk across the State and is a positive evolution of policy design. Several matters of concern and technical comments are raised in the submission.
- The public comment period closes on Monday, 17 July 2023

#### Recommendation

That WALGA endorse the submission on State Planning Policy 3.7 Bushfire and the Planning for Bushfire Guidelines.

#### STATE COUNCIL Item 7.3 Reforming WA Disability Legislation Submission

#### **Executive Summary**

- In March 2023, the Department of Communities (DoC) released the consultation paper 'Reforming WA Disability Legislation'.
- DoC is developing new disability legislation for Western Australia, largely driven by the State Disability Strategy 2020-2030 and the recommendations of the Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability.
- Under the current Disability Services Act 1993 (DSA), Local Governments are legislated to implement Disability Access and Inclusion Plans (DAIPs).

- WALGA has consulted with the sector and developed a submission with 11 key recommendations.
- The recommendations make the case for additional measures to support Local Governments implement DAIPs to deliver enhanced access and inclusion outcomes within local communities through standardized governance, training, support and funding

#### Recommendation

That WALGA endorse the submission to the Department of Communities relating to the Consultation Paper – Reforming WA Disability Legislation

#### STATE COUNCIL Item 7.4 Landfill Bans Advocacy Position

#### **Executive Summary**

- The State Government has committed to delivering a state-wide E-waste ban to landfill by 2024, with the aim of improving management and recycling of e-waste produced by households and businesses across the State.
- Consultation has occurred on the proposed ban and a WALGA Submission on this matter was endorsed by State Council in March 2023.
- A key recommendation of this and previous WALGA Submissions is that any material subject to landfill bans must be covered by a fully effective product stewardship scheme prior to ban implementation.
- Without effective product stewardship arrangements in place for items covered under landfill bans, the burden of managing the product at end of life falls disproportionately to Local Governments.
- A new advocacy position is proposed that makes it clear that landfill bans are not supported in the absence of effective product stewardship schemes, or other funding mechanisms, for products which would be subject to the ban.
- A contemporary and clear advocacy position on landfill bans will enable WALGA to strongly discourage this policy approach and advocate to the Government for the range of conditions necessary to increase resource recovery and reduce disposal of material to landfill.

#### **Recommendation**

That WALGA endorse the following Landfill Ban Advocacy Position:

Landfill bans are not supported in the absence of effective product stewardship schemes, or other funding mechanisms, for products which would be subject to the ban.

#### STATE COUNCIL Item 7.5 Audit Experience Survey Results Summary and Advocacy Position

#### Executive Summary

- In April, WALGA in partnership with LG Professionals WA conducted a survey of the Local Government sector to seek feedback on the annual audit process.
- A range of views were captured in the feedback, both positive and negative.
- The responses highlighted five key emerging issues in the audit process:
  - o timeframe and delays;
  - o additional workload on Local Government staff;
  - cost;
  - o inconsistent advice from contract Auditors and the OAG; and
  - asset valuation requirements.

 WALGA and LG Professionals will continue to work with the OAG to reform the audit process in line with sector feedback, with a particular focus on those issues above..

#### Recommendation

#### That:

- 1. State Council note the Audit Experience Survey Results Summary; and
- 2. WALGA advocate to the Office of the Auditor General (OAG) to reform the audit process for Local Governments by seeking:
  - a. Audits of Local Governments are completed and reported on in a timely manner and that the processes, procedures and scope of audits are consistently applied.
  - b. That the OAG review the requirements for pre-audit information with a view to reducing the need for additional information where possible;
  - c. That the OAG review their costing formulae for Local Government audits and show constraint in audit cost increases;
  - d. That the OAG provide a breakdown on the cost of the audit and justification for any variance to the estimate to the Local Government as part of the final billing process;
  - e. That auditors be required to improve their communication and information management and avoid repeated requests for information that has already been provided;
  - f. That Local Governments only be required to communicate with contract Auditors (unless the OAG is directly auditing the Local Government) and the onus be placed on the contract Auditors to confirm their advice with the OAG before instructing the Local Government; and
  - g. In-conjunction with the Department of Local Government, Sport and Cultural Industries, review the application of Fair Value principles in the context of the audit.

#### STATE COUNCIL Item 7.6 Amendments to WALGA's Constitution

#### **Executive Summary**

- At its last meeting, State Council resolved for two sets of constitutional changes to be developed for consideration by State Council, with the intention that Members would consider both sets of amendments at the 2023 Annual General Meeting:
  - One set to give effect to the alternate model, as per the <u>Best Practice Governance</u> Review Final Report; and
  - A second set to refine the current Constitution to address inconsistencies and other issues while maintaining the current governance model.
- The constitutional changes have been prepared by legal firm, Jackson McDonald.
- Amendments to the <u>Association Constitution</u> require both a special (75 percent) majority at State Council and a special (75 percent) majority at a General Meeting of Members.
- Consequently, if the proposed sets of amendments are endorsed by State Council, they will be put to the 2023 Annual General Meeting on Monday, 18 September.

#### Recommendation

That State Council endorse putting two items to the 2023 Annual General Meeting that:

- 1. propose a new Constitution to give effect to the alternate governance model as per the attached: and
- 2. amend the Constitution to retain the current governance model with necessary changes, as per the attached mark-up.

Zone Members are encouraged to provide a brief update on emerging issues in their District or matters on which they are seeking to connect with other Zone Members for direct collaboration or support.

#### 9.1.1. 2023/24 Financial Assistance Grants – Early payment

At the Australian Council of Local Governments last Friday the Prime Minister announced that the Government will be bringing forward 100 per cent of the 2023-24 allocation of Financial Assistance (FA) Grants into 2022-23, reflecting the complex financial environment all levels of government currently face, including the long term impacts of the pandemic.

This is a change to the arrangements announced in the 2023-24 Federal Budget, which would have seen 75 per cent of the 2023-24 Financial Assistance Grants advanced 'earlier in the financial year (2023-24) than would usually occur'.

Following the Budget, WALGA along with the National body (ALGA) and other State Associations, advocated strongly to the Treasurer for a continuation of the bring forward payment of FA Grants, which has been the established practice for more than a decade, under both Labor and Coalition Governments. Under these arrangements Local Governments have received 50 per cent of annual FA Grant payments brought forward as a lump sum at the end of the previous financial year, and in 2022-23 this was increased to 75 per cent to help manage the cumulative impacts of flood and the COVID-19 pandemic.

This is a good outcome, particularly for Local Governments that were relying on a bring forward. In our advocacy we stressed that for many Local Governments that have anticipated and developed budgets based on previous arrangements, not receiving this pre-payment would have a significant impact on cash flow, and especially for rural, remote and First Nations Local Governments that rely heavily on government grants.

I understand that Local Governments can expect to receive their payment by 30 June 2023.

# 9.1.2. Industrial Relations, Capital Works Cost Escalations, International Trade Relations – City of Albany

- The City of Albany is negotiating the City's Enterprise Bargaining Agreement for the first time under the State IR system, which has been referred to mediation. Expected to have significant labour cost implications for the Local Government.
- The City has recently received quotations evidencing a cost escalation of 20/30% for capital projects.
- The City recently received delegations from the Japanese Consulate and the Chinese Consul General, who both expressed interest in opening up new trade for quality products from the region.

#### 9.1.3. Wind Farm Developments – Shire of Broomehill-Tambellup

Heavy haulage associated with the development of wind farms has contributed to substantial damage to local roads, for which the Shire is now seeking damages from the company. The Shire recognises

that this is necessary infrastructure 'to keep the lights' on, but consider that more effort is required from State agencies and developers to better manage the impacts on local communities.

#### 9.1.4. Council Member Conflicts of Interest (CBH) - Shire of Cranbrook

The Shire of Cranbrook has been working with CBH on the development of 'load-in facilities', which require Ministerial approvals for the majority of Council Members to participate and vote on these matters, due to Council Member conflicts of interest. It was noted this is an onerous process, that is required each time a Council decision is required.

#### 9.1.5. Bush Fire Mitigation Activity Funding – Shire of Denmark

The Shire of Denmark received DFES funding for new firebreak works throughout the Shire, enabling mitigation works that would otherwise not be able to be undertaken. However funding is not provided to maintain these interventions and indicative maintenance costs for only these newly funded interventions was approximately \$100k p/annum. Maintenance of mitigation interventions was unsustainable for the Shire unless additional funding for maintenance purposes is provided.

# 9.1.6. Cultural Heritage Session, Residential Blocks Available, CEO Resignation – Shire of Katanning

- The Shire is hosting an Aboriginal Cultural Heritage information session on 29 June.
- Piesse Lake residential blocks have been released.
- Congratulations to the Shire of Katanning's CEO Julian Murphy who has resigned to take up the CEO's role at the Shire of Plantagenet.

#### 9.1.7. WALGA Convention Costs - Shire of Kojonup

Enquired why WALGA convention registration costs were so high.

WALGA CEO Mr Sloan advised the convention is conducted on a cost recovery basis only – WALGA does not profit from the convention. Costs associated with convention staging include - venue hire and servicing, sound and lighting, catering, speaker costs, etc.

# 9.1.8. Staff Attraction/Retention, Capital Works Costs, Activating Lazy Land – Shire of Plantagenet

By President Cr Chris Pavlovich, A/CEO Gary Clark

- Attraction and retention of qualified and experienced staff is an ongoing issue, with several current vacancies and impacts arising from long service leave and annual leave entitlements.
- Shire also experiencing substantial capital works cost escalations.
- Noted delays of up to 9-months for Western Power to provide quotes / cost estimates for headworks necessary to activate lazy land, which is impacting capacity to attract funding and investment. Western Power has now indicated that it will not quote for headworks unless there is a subdivision approval. Noted that Landgate approvals have similar delays and implications.

#### 9.1.9. Paleo Water Channel – Shire of Kojonup

By CEO Ms Kelly Bartley

CEO Ms Bartley advised that \$2.5M of water security funding has been allocated to the Shires of Woodanilling, Kojonup and West Arthur for the paleo water channel.

# **WALGA RoadWise**

## Regional Road Safety Advisor Report

Great Southern May-June 2023



WALGA's RoadWise has recently released the latest edition of the *Road Safety Performance Reports* for Local Governments. The reports identify priority treatment areas for Local Governments based on the main killed and serious injury (KSI) crash types.

The priority treatment for the Great Southern remains **run-off road crash** as they represent half the KSI crashes in the region.

One of the key challenges facing Local Government in managing the risk of run-off road or head on crashes is that they can happen anywhere on the vast road network. The Great Southern has 12,479km of local road network, which equates to 89% of the region's roads that carries only 29% of total travel use.

Added to this is the low traffic volumes, unforgiving road conditions with twoway high-speed traffic, roadside hazards and limited safety features.

#### **High Speed Local Roads Safety Project**

The Royal Automobile Association (RAC) has partnered with WA Local Government Association (WALGA), Main Roads WA and Australian Road Research Board (ARRB) to develop a business case for funding low-cost safety treatments that can be applied to the Local Government managed regional roads to reduce KSI crash risk.

ARRB has been commissioned to review up to 10,000km of sealed high-speed roads managed by local governments. A total of 482 Local Government managed roads have been shortlisted.

The proposed countermeasures include lane widening, centre and edge line delineation, shoulder sealing, audio tactile line marking, wide centreline treatment and hazard removal.

Local Governments are being consulted regarding the nominated roads within their jurisdiction and it is anticipated the business case will be submitted to the Australian Government in May/June 2023.

#### Tackling Road Safety Together – Great Southern Road Safety Conference 2023

Congratulations to the Shire of Cranbrook for hosting the 6<sup>th</sup> Annual Great Southern Road Safety Conference, Tackling Road Safety Together.

The annual event bought together approximately 45 road safety stakeholders from across the Great Southern Region.

Shire of Cranbrook CEO Linda Gray opened the event with local Noongar Elder Marie Eades Welcoming us to Country and Great Southern Police Superintendent Paul Coombes providing the welcome address.

The Conference covered a range of topics including:

- Road Safety Ratings for Local Government Roads Project Pilot with the City of Albany
- Road Safety for our Culturally and Linguistically Diverse Community for the Katanning Community
- Black Spot Program Review by Main Roads WA
- The First Responder Training Program for novice drivers, a community-based initiative by St John Ambulance
- Road Safety Demonstration Project and Road Traffic Safety Policy with Shire of Manjimup.

The keynote address was provided by Jimmy Murphy the founder of Town Teams Movement and this year's WA recipient of the Australia Day Local Hero Award. Jimmy spoke about the 'Community-led traffic calming in Mullalyup' and a partnership with the RAC and Road Safety Commission to expand the Town Teams Program to continue to address traffic calming through a placemaking approach.

The day concluded with a lively panel discussion 'ls reducing the speed limit an option for reducing Killed or Serious Injury Crashes'.

#### Department of Local Government, Sport and Cultural Industries Report

May 2023

#### Local Government Act Reform

- On 18 May 2023, the Local Government Amendment Bill 2023 was passed as the Local Government Amendment Act 2023 and assented to by the Governor.
- The following provisions have taken effect on assent for the Act:
  - o the ability of a local government to apply for a compliance exemption
  - o parental leave provisions for council members
  - o removal of the ability for a council to waive an interest arising from an electoral gift
  - changes to special electors' meetings to increase the number of signatures to 300 from 100 and allow a Mayor or President to direct that a special electors' meeting not be held on the same subject more than once in a 12 month period.
- A number of electoral reforms, including optional preferential voting and backfilling extraordinary vacancies, will take effect for the 2023 elections.
- The remainder of the reforms will be rolled out in the coming year, such as standardised meeting procedures, with regulations being developed in consultation with the sector.
- DLGSC is running a series of monthly webinars and deep dives into specific topics regarding the reforms in the upcoming months.
- The next webinar is scheduled for 1 June on upcoming ward and representation changes for local governments look out for LG Alerts for more details.

- DLGSC has also teamed up with LG Pro to deliver a series of capacity-building webinars. The next webinar is scheduled for 31 May.

# Model Financial Statements (MFS) and Financial Management Regulations Amendments

- Model Financial Statements (MFS) for Bands 1 and 2, plus a reduced version for smaller local governments (Bands 3 and 4) are now published on the DLGSC website.
- An LG alert was issued on Tuesday 15 May 2023 advising of their availability.
- The MFS will apply to 2022-23 annual financial statement reports.
- Guidelines have also been developed to accompany the MFS.
- A first tranche of regulatory amendments for the MFS commenced on 1 July 2022.
- A second tranche of regulatory amendments for the MFS are currently being drafted and are anticipated to be gazetted by 30 June 2023.
- DLGSC has received feedback from LG Professionals and WALGA with the proposed second tranche of regulatory amendments to support the introduction of the MFS and improved transparency in financial reporting obligations.

### Local Government (Functions and General) Amendment Regulations 1996

• The Local Government (Functions and General) Amendment Regulations 1996 were gazetted on Friday 19 May 2023. These amendments do the following:

#### **Rural GP and Dentists tender exemption**

- Recognising the importance of maintaining medical and dental services in our regions, a tender exemption for renewing or extending a contract with a medical or dental service is being provided to regional local governments.
- This exemption means those local governments will be able to maintain the services of an existing doctor or dentist without needing to call for public tenders.
- This exemption is only available to local governments outside the Perth Metropolitan Area and City of Mandurah.

#### **Novation of Contracts**

- An additional tender exemption is provided for where a local government novates a contract.
- As an example In the context of a dental service, this means where the dental practice is sold to another dentist, the local government can novate the existing contract with the old dentist to the new dentist.
- This improves local government contract management, allowing novation of contracts to occur, local governments should however make sure it is in their interest to novate he contract.
- This exemption is available to all local government.

#### **Dental leasing exemption**

- An exemption from the property disposal requirements has been provided for the leasing of land for dental services.
- This is to align with the new exemption provided for regional medical and dental services.
- This exemption is however available to all local governments, like the existing medical services exemption is.

# Early Intervention – Governance in the Western Australia Local Government Sector and DLGSC's Role

- DLGSC is replacing its Local Government Compliance Framework (developed in 2011) by adopting a new Local Government Regulatory Approach (Regulatory Approach).
- The Regulatory Approach is the primary framework that DLGSC will use to manage good governance across the local government sector by:
  - o fostering best practice through:
    - capability building;
    - compliance guidance; and
    - standard setting;
  - o understanding performance through:
    - intelligence gathering and analysis;
    - compliance reviews and audits;
    - consultation and support;
  - o ensuring compliance through:

- targeted assistance;
- investigation; and
- enforcement.
- The Regulatory Approach:
  - o reflects contemporary regulatory practices and all amendments to the Local Government Act 1995:
  - clearly defines DLGSC's local government regulation and support objectives, deliverables, and targets;
  - is cognisant of the reforms currently being considered and ensures DLGSC meets its obligations under the Local Government Act 1995; and
  - o provides for a clear commitment to early intervention, effective regulation supported by stronger penalties as part of the reforms to the Local Government Act 1995.
  - has been developed in consideration of best practice for anticipating and mitigating risk
- DLGSC's approach is focused on oversight and intervention where there are significant problems arising within a local government, and is supported by DLGSC's early intervention actions to address problems and dysfunction more quickly within local governments.
- As part of the reforms to the Act, the second tranche of reforms focuses on enhancing good governance in the local government sector by introducing the new Local Government Inspector and Monitors, with legislated powers for:
  - o early intervention actions supported by DLGSC;
  - monitoring of local governments and councils;
  - o providing statutory enforceable directions;
  - o undertaking investigations;
  - o determining complaints and issuing infringements; and
  - o undertaking enforcement actions.
- Current examples of DLGSC's early intervention actions can be seen with:
  - City of Swan
  - o City of Melville
- DLGSC's is focusing on early intervention with local governments that are not operating to the required governance standard. The early intervention model allows DLGSC to engage with at risk local governments to:
  - identify governance issues;
  - facilitate the local governments to accept that the governance issues have the real potential to cause dysfunction;
  - facilitate the local government to develop and implement good governance plans;
     and
  - provide regular contact and monitoring of a local government's progress in implementing good governance practices.
- One governance challenge that the local government sector is facing is meeting the
  requirements of the Local Government (Model Code of Conduct) Regulations 2021 that
  obligate local governments to self-regulate low-level council member behavioural conduct
  issues. Whilst these issues are low-level, they can have significant detrimental impact on
  council member relationships and without strong leadership on council, have the potential to
  escalate resulting in council dysfunction. The DLGSC is researching appropriate models to
  better advise and support local governments in managing these issues.
- The DLGSC applies a risk-based approach in respect of the support and intervention actions, applied on a relative scale, in engaging with local governments. As part of this approach, DLGSC obtains financial, compliance and conduct information and statistics from all local governments, which when interpreted holistically indicate a local government's performance level.
- The performance indicator information related to each local government is published on the MyCouncil website at: https://www.mycouncil.wa.gov.au/ with the intention to expand the

information reported to allow deeper analysis and a better understanding of individual local government performance and on a sector level.

#### Stop Puppy Farming

- The Dog Amendment (Stop Puppy Farming) Bill 2021 was passed by the Parliament in December 2021.
- The new laws, including for the registration and breeding of dogs, will take some time to implement.
- There will be consultation with stakeholders, including local governments, for the design and development of a centralised registration system (CRS) for dogs and cats covered under the *Dog Act 1976* and the *Cat Act 2011*, and for the development of regulations to give legal effect to the functions of the CRS.
- The DLGSC conducted engagement activities with local governments in the second half of 2022. Through this, local government requirements for the CRS were captured for inclusion within the system requirements and scope.
- Progression towards procurement of the CRS and scoping of the regulations is underway. The Request for Tender for the CRS was released to the market on 24 January closed on 8 March 2023.
- The DLGSC is currently evaluating tender responses received.
- The DLGSC is continuing to engage with key stakeholders to support ongoing progress towards the reforms.

#### Introduction

Local Government plays a key role in biosecurity management in Western Australia. Local Governments' involvement in biosecurity ranges from assisting with early detection and reporting of pests and diseases, participating in State responses to biosecurity incursions, managing declared pests on lands owned under State law, working in partnership with Recognised Biosecurity Groups on control activities for declared pests, developing and enforcing pest management local laws, and supporting community groups to implement management actions for pests and diseases. It does this through organisational leadership, building and utilising strong networks and partnerships with stakeholders, and delivering on-ground action.

The Biosecurity and Agriculture Management Act 2007 (BAM Act) came into effect in May 2013 with the Biosecurity and Agriculture Management Regulations 2013. The Minister for Agriculture and Food has responsibility for administering the Act and is required to carry out a review every ten years from commencement.

In March 2022, the State Government appointed an independent <u>review panel</u> to undertake the statutory review. The panel has been tasked with assessing the extent to which the BAM Act provides a fit-for-purpose, efficient and effective legal framework to underpin a word class biosecurity system, and related agricultural management, for Western Australia.

The review is being undertaken in a three stage public consultation process:

• Stage 1 identify themes invited open submissions on key issues relevant to the review of the BAM Act, and occurred from 16 June to 27 July 2022. A total of 113 submissions were received from a diverse range of stakeholders, including government representatives, community groups, NGOs and landholders. WALGA submitted a <u>Discussion Paper</u> that identified 11 key biosecurity management themes for the Local Government sector, and met with the review panel on 5 September 2022 to discuss these further.

Key points from the Stage 1 consultation period included:

- the BAM Act is working well but has inconsistency in application, and uncertainty about roles and responsibilities
- border biosecurity is addressed well
- the risk and impact of harmful pests, weeds and diseases in WA is growing, with some improvement in management needed
- WA's biosecurity system is not appropriately balanced to deliver social, environmental and economic outcomes, with a focus on agricultural management
- o more work needs to be done to achieve compliance
- o improved efficiencies, resourcing and funding for biosecurity are needed
- o biosecurity communication and education are needed
- Recognised Biosecurity Groups funded by declared pest rates may not be the best way of supporting a community-led approach.
- Stage 2 explore themes considered the range of issues identified during Stage 1, and selected four key themes that stakeholders saw as important to explore in more detail:

- 1 **principles to underpin WA's biosecurity**, including biosecurity in all contexts and shared responsibility
- 2 **legal foundations of WA's biosecurity**, including prioritising pests, weeds and diseases, and enabling industry and community action
- 3 planning, coordinating and resourcing WA's biosecurity system, including responsibilities and timing
- 4 **community-led pest and weed management**, including the Declared Pest Rate and Recognised Biosecurity Groups.

Stage 2 delved into the challenges and asked questions on what could be improved to inform the development of options and solutions. Feedback was sought through discussions with the review panel, workshops with DPIRD staff, and an online survey between 27 October and 4 December 2022.

WALGA participated in a policy workshop on the Declared Pest Rate and Recognised Biosecurity Groups on 20 September 2022.

WALGA partnered with DPIRD to host a consultation workshop for the sector on 24 November 2022, with Local Governments from across the State providing input.

• Stage 3 solutions and reporting presents legislative and non-legislative reform opportunities identified during the previous stages together with additional research in a <u>Discussion Paper</u>, and is open for feedback for five weeks until 30 June 2023.

There are nine areas identified for reform, with desired outcomes and ways in which these might be achieved outlined for each. The feedback will help the review panel finalise its recommendations to the Minister later in 2023.

The discussion paper does not address matters relating to technical amendments raised by stakeholders during the consultation process to date, however these will be included in the review panels final report to the Minister.

# **Purpose of this Draft Submission**

This draft submission summaries the nine areas for reform, target outcomes and suggested improvements identified in Stage 3 Discussion Paper. Alignment of the target outcomes with the WALGA Biosecurity Advocacy Position, and potential benefits or issues for the reform opportunities, are outlined.

As well as responding to Stage 3 of the BAM Act Review directly, Local Governments are also strongly encouraged to provide WALGA with feedback on the opportunities for reform by COB, Monday 26 June via <a href="mailto:environment@walga.asn.au">environment@walga.asn.au</a>. The feedback received will be incorporated into WALGA's Stage 3 submission to the BAM Act Review on behalf of the sector.

Further information on how to submit a response is provided in Section 6 of this paper.

# Biosecurity and Agriculture Management Act 2007

The BAM Act and associated regulations are the legal framework that supports biosecurity and agriculture management for the Western Australia by providing the essential powers and duties that enable:

- leadership in the biosecurity system
- shared responsibility, including funding arrangements and cost recovery for some areas of biosecurity
- surveillance for pests, weeds and diseases
- prevention and timely responses to incursions
- long-term management of pests, weeds and diseases that have established in WA
- management of the sale and use of agricultural and veterinary chemicals.

In December 2013, an assessment by the Office of the Auditor General, <u>Managing</u> the <u>Impact of Plant and Animal Pests: A State-wide Challenge</u> found that the BAM Act was failing to achieve state-wide pest management, due to the lack of an integrated approach across the State, lack of clearly defined roles and responsibilities of government agencies, limited monitoring of pests and no enforcement of the regulations, among other reasons.

The State Government responded to the Auditor General's report by developing the <u>Invasive Species Plan for Western Australia 2015-2019</u> and the <u>Western Australian</u> <u>Biosecurity Strategy 2016-2025</u>.

The WA Biosecurity Strategy sets the overall direction for the management of emerging and ongoing biosecurity issues within the State, and is underpinned by three principles:

- biosecurity is a shared responsibility
- effective risk management underpins decision making
- policies and programs are transparent, consistent and evidence based.

In 2020, the <u>Auditor General conducted a follow-up audit</u> which found that State Government had not effectively addressed all the findings from the 2013 audit, although some progress had been made.

# WALGA biosecurity advocacy position

WALGA's current Biosecurity Advocacy Position was endorsed in December 2022 and replaces the previous positions from 2017 and 2006. It was developed following sector consultation on WALGA's Discussion Paper for Stage 1 of the BAM Act Review. The draft Advocacy Position was considered in November 2022 by each of the 12 Country and 5 Metropolitan Zones in WA, which are groups of geographically aligned member Local Governments responsible for providing input into policy formulation. State Council then endorsed the Advocacy Position at the meeting on 7 December 2022.

#### WALGA's Advocacy Position 4.5 Post Border Biosecurity states:

Western Australia's economy, environment and the community are facing increasing challenges posed by already established and new pests, weeds and diseases.

Local Government has a significant role in biosecurity management, as land managers and regulators, and therefore has an interest in ensuring that Western Australia's biosecurity system, including control of declared pests, is effective and appropriately resourced.

WALGA considers significant changes to the operation of the State's biosecurity system, including the Biosecurity and Agriculture Management Act 2007, are required to ensure these risks can be managed now and into the future.

To be effective the Western Australian biosecurity system must:

- 1) Take a transparent approach to the notion of 'shared responsibility' by ensuing that:
  - a) The respective roles and responsibilities of Commonwealth, State and Local Government, industry, landholders, community groups and individuals are agreed and clearly articulated; and
  - b) There is improved pest management on State Government managed land and a formalised structure for State Government agencies with responsibilities for biosecurity management to work together and coordinate their activities.
- 2) Be underpinned by a strategic framework, developed in collaboration with stakeholders, that:
  - a) Establishes priorities for biosecurity threats in geographically defined regions, sets measurable targets and guides investment in biosecurity activities; and
  - b) Is regularly evaluated and reported on.
- 3) Have a greater focus on environmental biosecurity, through the increased recognition and management of pest species that have significant ecological impacts.
- 4) Be adequately, sustainably and equitably funded:
  - a) The appropriateness and effectiveness of the Declared Pest Rate (DPR) and Recognised Biosecurity Group (RBG) model as key mechanisms for the management of widespread and established declared pests should be reviewed and alternate mechanisms considered:
  - b) Increased and more equitable distribution of funding for every step in the biosecurity continuum and adequate resourcing for all stakeholders, including Local Government; and
  - c) The provision of funding for declared pest management in metropolitan areas.
- 5) Ensure that the criteria and process for listing of declared pests is evidence-based, timely and transparent.
- 6) Have an increased emphasis on compliance through education and enforcement activity, to ensure land managers are aware of their legislative responsibilities and are supported to implement biosecurity actions.

- 7) Facilitate the use of new technologies, strategic monitoring, and the establishment of data management systems to inform biosecurity investment decisions and support adaptive management.
- 8) Improve the community's understanding, awareness and action in relation to biosecurity to assist with threat surveillance and timely response to incursions.

# **Biosecurity reform areas**

Stage 3 of the BAM Act Review sets out nine priority reform areas:

- Reform Area 1: Clarifying the role of the BAM Act
- Reform Area 2: Working together to protect WA
- Reform Area 3: Planning and reporting- vital to a better biosecurity system
- Reform Area 4: Prioritising pests and diseases
- Reform Area 5: Emergency powers- a necessary precaution
- Reform Area 6: Compensation can boost biosecurity efforts
- Reform Area 7: Enabling industries to act
- Reform Area 8: Community-led pest management
- Reform Area 9: Compliance with WA's biosecurity laws.

Within these nine reform areas, there are 21 opportunities identified to clarify, strengthen and support a strengthened biosecurity system in WA.

WALGA has reviewed the nine reform areas, the target outcomes and the suggested opportunities for improvement. Alignment of the target outcomes with the WALGA Biosecurity Advocacy Position, and anticipated benefits or issues for the reform opportunities, are outlined in **Table 1**.

WALGA is seeking feedback on the benefits and issues of the proposed reform opportunities, as well any additional important considerations that Local Governments would like to see included.

The <u>Stage 3 Discussion Paper</u> outlines several significant legislative and non-legislative changes to the current biosecurity management arrangements:

- The establishment of a formal biosecurity body, with representatives from all biosecurity system participants, to provide strategic leadership for biosecurity through the development and oversight of a plan for the collaborative management and prioritisation of investment in pests and diseases across WA.
- A simplified framework and assessment process for 'biosecurity matter', which
  would be further defined as prohibited, restricted or permitted matter based on
  the level of risk presented to WA to replace the current assessment and
  declaration of individual organisms as unlisted, permitted, prohibited or
  declared pests.
- The Declared Pest Rate would change to a uniform ad valorem rating structure applied to the entirety of WA to land of sufficient size, and retain the State Government legislated dollar-for-dollar matching of funds raised. The pooled funds would be apportioned to priority pest management and compliance programs by the formal biosecurity body, with direction from local/regional levels, and also provide base-level funding for coordinating local/regional pest management activities.

- The range of pest management entities that are eligible to receive pooled funds would be broadened from Recognised Biosecurity Groups to include Local Government, regional NRM groups, Landcare and Aboriginal groups, and others, with co-contributions required from funding recipients.
- The scope of Local Government local laws will be expanded to apply to any widespread and established pest animal or plant.
