6. ZONE BUSINESS

6.1 September 2022 Regional State Council Meeting

Each year, the WALGA State Council meets in a regional location hosted by a Zone to engage in a Zone Forum and/or a tour of local amenities, recent projects, or points of interest. There are generally two regional State Council meetings per year – one hosted by a Metropolitan Zone and another hosted by a Country Zone. Regional meeting hosts are rotated between the Zones.

It is proposed that the September 2022 regional State Council meeting be hosted by the Peel Country Zone.

Regional meetings afford State Council the opportunity to meet with Elected Members and senior officers from Local Governments within a region, to discuss issues of local and regional significance. They also allow State Councillors to meet with other regional groups of interest to gain a first-hand appreciation of the various issues confronting Local Governments in each region.

The last time a regional State Council meeting was hosted by the Peel Country Zone was in 2012 in Mandurah.

It is proposed that the 2022 regional meeting be held over two days, Thursday and Friday, 8-9 September.

The general requirements for a location to host the regional State Council meeting are:

- the ability to accommodate State Council and WALGA staff (approx. 35 rooms required);
- a venue for the Zone Forum and State Council meeting (approx. 60 attendees); and
- a venue to host a dinner for the WALGA group plus Zone members (approx. 60 attendees).

In terms of cost to the Zone, WALGA would request a contribution from Zone members for catering at the Zone Forum and dinner event on a per-head attended basis. WALGA would also be seeking use of Local Government facilities (if available) as a venue for the Zone Forum and State Council meeting. WALGA will pay for all costs associated with the State Council meeting and Strategic Forum. Zone members are welcome to be observers for these meetings.

The Zone will need to consider a program. Liaison will be with WALGA's Strategy and Association Governance Team.

Peel Zone to consider hosting the Regional Zone Forum and State Council meeting and advise WALGA accordingly.

WALGA confirmed that the only contributions from the Zone would be the cost of additional councillors or staff attendees. Mandarah indicated it was happy to host the event. The Chair would discuss this further with WALGA and then come back to the Zone offline.
