2.0 UPDATE FROM CHAIRPERSON

2.1 Update on meetings in past few months.

The Chair outlined various meetings attended with the Vice-Chair and SportWest, WALGA and State Sport Associations to highlight MARAG's role and to strengthen opportunities for collaboration and alignment.

3.0 PRESENTATIONS

3.1 SportWest – Rob Thompson, CEO provided a presentation on the following:

- SportWest, formerly WA Sport Federation, established in 1974 and has 130 members.
- SportWest is part of the national body Community Sport Australia of which there are other State associations in Queensland, South Australia, New South Wales and Victoria.
- The Australian Sports Commission (ASC), established in 1985, is the
 Australian Government agency responsible for supporting and investing in
 sport and physical activity at all levels. The ASC unites two entities: 1. Sport
 Australia responsible for driving the broader sport sector including
 participation, physical activity and industry growth and 2. The Australian
 Institute of Sport leading our high performance sport system.
- Move It Australia Infrastructure Grants. The group raised that many grants
 were submitted by clubs without Local Government support, with grants
 awarded and Local Governments left to quickly pick up the pieces. The group
 also noted the lack of understanding from the Commonwealth Government
 regarding Local Governments processes, the political nature of the grants and
 the one-off nature rather than continuing the grants into the future.
- CSRFF continued advocacy required to increase the funding to address the oversubscription for project funding.
- There are advocacy opportunities with MARAG, a unified voice.
- MARAG members to provide feedback to SportWest on opportunities for collaboration.

3.2 Western Australia Local Government Association (WALGA) – Joanne Burges, Executive Manager People & Place provided a presentation on the following:

- WALGA is providing administrative support to the MARAG and WALGA can also provide an opportunity for MARAG to advocate and collaborate on policies and strategies.
- At WALGA's 2019 Local Government Convention in August, a concurrent session focussed on sport infrastructure funding with participation from Rob Thompson (SportWest) and Stephen Cain (CEO, City of Cockburn).

- An outcome from WALGA's concurrent Local Government Convention session, was to hold a roundtable with key stakeholders to further discuss sport infrastructure funding, in terms of CSRFF as well as the development of a regional sport infrastructure facilities investment strategy.
- The roundtable was hosted by WALGA's CEO with SportWest, WA Football Commission, WA Cricket Association, Netball Western Australia, Local Government CEO's represented on the Greater Area Perth and Peel Group (GAPP) from Wanneroo, Cockburn, Swan and Rockingham, Infrastructure WA, Department of Planning, Lands and Heritage, and the Department of Local Government. Sport and Cultural Infrastructure.
- The roundtable session informed WALGA's State Government 2020-2021 Budget Submission which is advocating for two areas: 1. Increase the annual amount of grant funding available in the Community Sport and Recreation Facilities Fund (CSRFF) to \$25 million and 2. Develop a long-term, Regional Sports Facilities Investment Strategy.

3.3 Sports Environment Alliance – Dr Sheila Nguyen, Co-Founder and Executive Director, provided a presentation on the following:

- The Sports Environment Alliance (SEA) is committed to do more {for the world} with less {footprint} so we can continue to have places to play. The Sports Environment Alliance (SEA), established in 2015, is committed to do more for the world with less footprint so we can continue to have places to play. The mission of SEA is to lead, educate, and inspire the sport community members to learn, share, and act for a more sustainable & regenerative Australasia.
- SEA is a membership based organisation, offering events, resources, best practice advice and advocacy.

3.4 Department of Local Government Sport & Cultural Industries (DLGSC) – Rob Thomson, Director Infrastructure Planning and Investment provided a presentation on the following:

- The Infrastructure Planning and Investment section of DLGSC is relatively new and have been operating for the last 12 months.
- Primarily the team has been focussed on delivering election commitments (approximately 200).
- The team developed business cases for further investment in CSRFF and regional infrastructure investment. This information was provided to WALGA to inform the State Government 2020-2021 Budget Submission.
- CSRFF have been analysing the benefits/value of the funding to Local Governments, if the timing of the funding is suitable for Local Governments etc. Feedback is welcomed from Local Governments.
- There was a query regarding presenting to Local Government Councillors on the value of CSRFF. DLGSC have provided presentations in the past.
- There was a query regarding Kidsport and whether it will continue. ACTION:
 DLGSC to provide feedback to MARAG regarding Kidsport.

3.5 Parks and Leisure Australia WA (PLAWA)-Leith Fradd, CEO provided a presentation on the following:

 The Community Facilities Guidelines has been released for comment with feedback closing on 1 January 2020. This report is a high level overview of the current provision of public open space (POS) and community level sport infrastructure provided by Local Governments. Information sessions have already been held in various areas.

- The Leisure Facilities Managers course was released in August. It is aimed at first time facilities managers and is a beginner's course. It is anticipated there will be development of Level 2 and Level 3 courses.
- The Awards will open in January
- The National Conference was held this year. The State Conference occurs
 every two years and MARAG members are asked to consider nominating to
 be on the organising committee.
- A Leisure Planners course will be scoped in January with the intention of finalising this at the end of 2020.
- The Chair of MARAG asked members to brainstorm areas for professional development that PLAWA may help with and the following was considered as a priority:
 - Courses to assist with facilitating groups empowering and collaborating examples
 - Data at the localised level
 - Advocacy skills and tools, for example Armadale Sport Advocacy Resource.
 - o Local Government Elected Member training.
 - Community engagement.
 - Storytelling from projects and celebrating achievements.
