- As an officer employed by a Member Local Government; or
- As an employee of WALGA.

##### PRESENTED IN RECOGNITION OF:

- Outstanding contributions to the Local Government sector.
- Demonstrated leadership.
- Outstanding achievements in the advancement of the Local Government sector.

##### PRIVILEGES

- Local Government Distinguished Officer Award certificate.

### IMPORTANT NOTES

Nominations must be submitted via email to [honours@walga.asn.au](mailto:honours@walga.asn.au) before the closing date of **Friday, 24 June 2022**.

- Please refer to the nominating authority section on the next page to ensure that an eligible nominator has been identified to support the nomination.
- Nominations from Member Local Governments require the support of the Nominator (who must be an Elected Member) plus two other Elected Members and the Mayor / President.
- Nominations submitted by State Councillors do not require supporting signatures.
- When submitting your nomination, please also provide a high-resolution photo (no less than 1mb in file size) of the Nominee. The photo should be passport type (head and shoulders) and in colour.
- Nominations will not be accepted for persons who have retired or ceased working for Local Government before 31 December 2019.
